Utah State joining rebuilding Pac-12

The Pac-12 officially has its seventh member.

Utah State will be joining the Pac-12 on July 1, 2026, it announced Tuesday, becoming the fifth Mountain West school to defect to the rebuilding conference.

The Pac-12 said the conference board of directors voted unanimously to admit Utah State, which will compete in the conference in all sports beginning in the 2026-27 academic year.

“Utah State brings invaluable strategic insights and leadership that will greatly benefit our conference and its members as well as a history of competitive excellence and success. Today marks another exciting step for the Pac-12 – and it’s just the beginning of phase two,” Commissioner Teresa

Gould said in a statement.

The addition of the Aggies to the Pac-12 gives the conference seven universities. In addition to Washington State and Oregon State, the only two remaining members after this summer’s mass exodus, Boise State, Colorado State, Fresno State and San Diego State announced they were bolting to the Pac-12 less than two weeks ago.

The official announcement of Utah State came the same day the Pac-12 filed a lawsuit against the Mountain West. The two sides are in a scheduling agreement in football for this season for the Cougars and Beavers, but the Pac-12 is seeking declaratory relief from a judge over millions of dollars in penalties the Mountain West believes it is owed from the Pac-12 for acquiring its schools. The current scheduling agreement calls for the Pac-12 to pay the Mountain West a withdrawal fee of \$43 million if it

poaches four MWC teams and \$67.5 million if it poaches six, according to a copy of the agreement obtained by USA TODAY Sports.

With seven members, the Pac-12 is one school shy of meeting NCAA rules for the Football Bowl Subdivision, which requires leagues have a minimum of eight. The Pac-12 is being allowed to operate as a two-team league under a two-year grace period until July 2026. Since Utah State is departing, the Mountain West is also left with seven members and will likely need to expand to meet the NCAA requirements.

Earlier this week, the Pac-12 was interested in adding American Athletic Conference members Memphis, South Florida, Tulane and UTSA. However, the four schools announced Monday their commitment to the AAC.

2-time defending WNBA champ Aces move on

Kelsey Plum matched her career playoff high with 29 points on Tuesday night while WNBA MVP A’ja Wilson added a double-double as the fourth-seeded Las Vegas Aces beat the visiting Seattle Storm 83-76 for a two-game quarterfinal sweep.

The two-time defending league champion Aces will start a best-of-five semifinal series Sunday on the road against the top-seeded New York Liberty. Las Vegas lost all three games in the regular-season series with New York but looked more like its championship self down the stretch, going 9-1 to end the campaign.

Plum hit 11 of 15 shots from the field, while Wilson added 24 points and a game-high 13 rebounds as the Aces dominated the glass 45-30. Las Vegas’ Chelsea Gray contributed 12 points and nine assists.

Gabby Williams scored 20 points to lead fifth-seeded Seattle, while Nneka Ogwumike added 16 points and 10 rebounds. Ezi Magbegor returned from missing the previous four games with a concussion and tallied 14 points. Skylar Diggins-Smith chipped in 13 points and 10 assists.

The Storm took their only lead of the night with 7:58 left in the game on a put-back by Mercedes Russell, but Las Vegas quickly regained control with seven straight points. Jackie Young scored in transition for a 71-65 advantage with 6:05 remaining, and the Aces stayed in front from there.

Las Vegas got off to a strong start in its bid to eliminate Seattle, with Plum and Wilson each putting up 12 points

in the first quarter.

Sabrina Ionescu scores 36 points as Liberty sweep Dream

Sabrina Ionescu poured in a playoff-career-high 36 points, Jonquel Jones had a double-double and the New York Liberty completed a 2-0 sweep of the Atlanta Dream with a 91-82 home win on Tuesday.

The top-seeded Liberty, who beat the eighth-seeded Dream 83-69 on Sunday in Game 1 of the best-of-three series, advanced to the semifinals for the second year in a row.

New York is off to face the fourth-seeded Las Vegas Aces, who completed a 2-0 sweep of their own Tuesday over the Seattle Storm, the No. 5 seed.

Ionescu shot 12-for-23 from the floor, including 5-for-11 from 3-point range, and added nine assists. She put the Liberty ahead for good with a 3-pointer that made it 70-67 with 7:17 left in the fourth quarter.

Jones scored 20 points on 8 of 12 shooting and grabbed 13 rebounds. Breanna Stewart added 13 points and Leonie Fiebich had nine for New York.

Allisha Gray put up 26 points to lead Atlanta, which was swept out of the first round of the playoffs for the second straight season. Rhyne Howard had 19 points, Tina Charles added 14 and Naz Hillmon paired six points with 10 rebounds.

The Dream pulled even at 67 on Nia Coffey’s 3-pointer with 9:01 to go and trailed 73-72 after Gray’s fifth trey of the night with 6:03 to play. The Liberty took over from there, rattling off a 12-2 run to put the game out of reach.

New York went up 82-74 on Fiebich’s three-point play before Fiebich’s 3-pointer made it 85-74 with 3:37 left. The Liberty maintained at least a seven-point lead the rest of the way.

New York made eight more free throws than Atlanta and had an 18-11 edge in points off turnovers.

The Dream led 28-19 after a perfect first quarter from Gray, who scored 14 points on 5 of 5 shooting, including four 3-pointers. She went scoreless in the second as the Liberty used a 21-8 run to go up 40-36 midway through the quarter. Atlanta responded with a 12-3 surge to enter halftime leading 48-43 after Charles’ jumper with three seconds left in the first half.

The Dream went ahead 55-47 on Howard’s 3-pointer before New York charged ahead 63-59 with 1:52 left in the third quarter. Ionescu delivered 11 points in the third for the Liberty, while Gray ended her drought with a late flurry to pull Atlanta within 65-64 entering the fourth.
