A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE AWARD OF BID TO ADVANCED DISPOSAL SERVICES SOLID WASTE SOUTHEAST, INC., IN RESPONSE TO ITB 14-009, FOR SOLID WASTE COLLECTION AND PROCESSING SERVICES; AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT IN SUBSTANTIAL CONFORMANCE WITH THE BID DOCUMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, two proposals were received in response to ITB 14-009, and the proposals were opened by the City Clerk on March 5, 2014; and

WHEREAS, City staff, along with Kessler Consulting, a solid waste consulting firm engaged by the City, reviewed the submittals, and found the proposals each to be responsive with good references and solid financial standing; and

WHEREAS, City staff and the consultant evaluated the proposals and recommended a contract award to Advanced Disposal which includes 1-1-1 single day collection (trash/recycling/yard waste residential pickup), commercial franchise, recycling/yard waste processing, and servicing right-of-way containers, without operation of the City's Transfer Station. City staff and the consultant determined that contract would be most beneficial to the City and its business community, and recommends award of the

bid based on those parameters.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the proposal of Advanced Disposal Services Solid Waste Southeast, Inc., including the 1-1-1 Service Option, commercial solid waste franchise, recyclables/yard waste processing and servicing right-of-way containers, without transfer station operation, is hereby approved in accordance with the terms and conditions contained in Invitation to Bid #14-009 and response thereto.

Section 2: That the City Manager, upon the advice and consent of the City Attorney, is authorized to enter into a contract in substantial conformance with the bid documents.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
