NARRATIVE OF INCIDENT

On Tuesday, October 14th, local man wanted for a recent rash of crimes and on the run from law enforcement was captured by Key West Police Department Officers and Detectives with the Criminal Investigations Unit. 30 year old, Pablo Sanchez, who's criminal record in the lower keys and Key West extends well over a decade, was spotted by Detectives in the area of George Allen Housing in Key West around 2:40PM. Sanchez, knowing that he had active warrants for his arrest in relation to grand theft and burglary, fled upon sight of law enforcement officers.

A perimeter was immediately set by Key West PD to surrounding the George Allen complex and keep Sanchez from escaping. Following a foot pursuit in multiple directions within George Allen, Sanchez was apprehended by Detectives with the Criminal Investigations Division on the 1st Street side of George Allen. A Taser was utilized during the foot chase and Sanchez was taken into custody with minor injuries. There were no reported injuries to Officers or Detectives.

Detectives were equipped with "POLICE" exterior patches and officers were wearing class B uniforms. Orders were verbally given to Sanchez and he continued to flee.
