A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RATIFYING AN EMERGENCY PROCUREMENT DATED APRIL 19, 2021 APPROVED BY THE INTERIM CITY MANAGER AS PROVIDED FOR UNDER SECTION 2-797(2) OF THE CODE OF ORDINANCES, AUTHORIZING A TASK ORDER IN AN AMOUNT NOT TO EXCEED \$128,339.87 FOR CHARLEY TOPPINO & SONS, INC. TO REPAIR 25 MANHOLES ON NORTH ROOSEVELT BOULEVARD; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 15-292, the City Commission approved a three-year General Utilities contract with Charley Toppino & Sons, Inc. and in Resolution 18-322 the Agreement was renewed for two additional years. The City is in the process of re-bidding new General Utilities contracts, however Toppino's provided a price quote for this project based on the 2018 General Utilities Contract pricing; and

WHEREAS, staff has identified that failing manhole rings are an immediate concern on North Roosevelt Blvd, and expeditious repairs are necessary to prevent a potentially dangerous situation; and

WHEREAS, the City Manager has determined that delaying this project could cause a public safety hazard; and

WHEREAS, the City Manager acted without delay, using emergency powers authorized under Section 2-797(2) of the City's Code of Ordinances, to authorize and procure the necessary task order to ensure prompt repair of 25 manholes on North Roosevelt Boulevard; and

WHEREAS, Section 2-797(2) of the City's Code of Ordinances requires the City Commission to ratify such emergency purchases at its next scheduled meeting.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached emergency task order dated April 19, 2021 by the City Manager, pursuant to section 2-797(2) of the Code of Ordinances, for repair of 25 Manholes on North Roosevelt Boulevard, by Charley Toppino and Sons, Inc in an amount not to exceed \$128,339.81 is hereby ratified.

Section 2: That this task order will be paid from budget line 401-3503-535-4600, sewer/renewal and replacement/repairs and maintenance, and any necessary transfers or adjustments are hereby authorized.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
