

RESOLUTION NO. 20-039

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING STAFF RANKING AND AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND EXECUTE CONTRACTS ON A TASK ORDER BASIS TO FOUR FIRMS IN RESPONSE TO REQUEST FOR QUALIFICATIONS NO. 20-002 FOR ENVIRONMENTAL ENGINEERING SERVICES; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City issued a Request for Qualifications for engineering firms capable of providing environmental engineering services; and

WHEREAS, nine firms responded, and at a public meeting on February 4, 2020, a committee comprised of City staff members reviewed the responses, and determined four firms to be particularly qualified, and recommended that the City engage each one on a Task Order basis;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the responses for environmental engineering services are hereby ranked by staff, and approved by the City Commission as follows:

- (1) Tetra Tech, Inc. (Tetra Tech)
- (2) Atkins North America, Inc. (Atkins)
- (3) GHD
- (4) E. Sciences

Section 2: That the City Manager is hereby authorized to negotiate and execute contracts on a task order basis with each of the companies in order of ranking, upon advice and consent of the City Attorney, for a term not to exceed three (3) years, with an option for one two-year extension.

Section 3: Specific task orders issued pursuant to the contracts shall comply with the City's procurement guidelines.

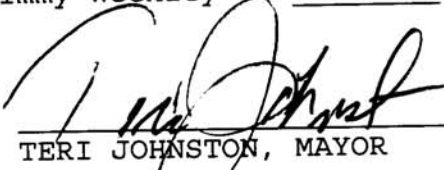
Section 4 That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.

Subject: Approving ranking of firms submitting responses to Request for Qualifications (RFQ) # 20-002 for Environmental Engineering Services

Action Statement

Approving staff ranking of firms submitting responses to RFQ 20-002: Environmental Engineering Services and authorizing City Manager to negotiate and pursuant to legal review enter into contracts with top four (4) firms.

Background

To continue the service specialty diversification of engineering firms currently under Engineering Services agreements (Resolution 12-280), the City issued RFQ 20-002: Environmental Engineering Services on December 9, 2019. On January 08, 2020, the City received nine (9) responses to the RFQ from the following firms:

1. Atkins
2. Cardno
3. Coastal Technology
4. E. Sciences
5. GHD
6. HWA
7. Terracon
8. Tetra Tech
9. Wood

On February 4, 2020, a selection committee of City staff met at a publicly advertised meeting to present RFQ rankings (attached) of the nine firms based on the Selection Criteria Matrix from the RFQ.

The engineering Department having reviewed the ranking, recommends negotiating and entering into

Environmental Engineering Services Ranking
the contracts with the following top 4 firms from the ranking.

February 19, 2020

- (1) Tetra Tech, Inc.
- (2) Atkins North America, Inc.
- (3) GHD
- (4) E. Sciences

The City typically contracts with multiple firms to address specialized services. The four (4) recommended Environmental Engineering Services firms will provide the City with the necessary environmental services to address anticipated needs for future projects.

The term of contracts shall be for a period of three (3) years with the option of one (1) two (2) year renewal.

OPTIONS

1. Accept the rankings of Staff and authorize City Manager to negotiate, and pursuant to legal review, enter into a contract with one or all four listed firms;
2. Modify Staff ranking and authorize City Manager to negotiate, and pursuant to legal review, enter into a contract with one or all of the firms of the modified ranking;

Financial Issues

There are no financial obligations with ranking and entering into contracts with each of the short-listed firms. These will be task order based contracts with which a dollar amount will have to be approved along with the task order per City Ordinance.

Recommendation

Engineering staff recommends the City Commission accept Staff rankings and authorize City Manager to negotiate, and pursuant to legal review, enter into contracts with the four (4) highest ranked firms.
