A RESOLUTION OF THE CITY COMMISSION CITY OF KEY WEST, FLORIDA, APPROVING THE RANKING OF **RESPONSES** THE REQUEST FOR QUALIFICATIONS 23-007 NO. BYTHE **SELECTION** (RFQ) COMMITTEE FOR THE FOGARTY AND 3RD PUMP ASSISTED INJECTION WELL; AUTHORIZING THE CITY MANAGER TO NEGOTIATE A CONTRACT WITH THE HIGHEST RANKED FIRM, ENGINEERING GROUP, INC. UPON ADVICE AND THE CITY CONSENT OF ATTORNEY; **NECESSARY** AUTHORIZING ANY BUDGET ADJUSTMENTS OR TRANSFERS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City issued a Request for Qualifications for firms capable of providing professional design services for stormwater utility infrastructure for the City of Key West; and

WHEREAS, the City Clerk opened two responses to the RFQ on November 1, 2023, all of which were deemed responsive and responsible; and

WHEREAS, the Fogarty and 3rd project will be substantially funded through a State of Florida Department of Economic Opportunity Community Development Block Grant-Mitigation Agreement approved in Resolution 22-211; and

WHEREAS, a Selection Committee, consisting of City staff evaluated and ranked the proposals at a public meeting on November 15, 2023; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That based upon the criteria set forth in RFQ No. 23-007, for Fogarty & $3^{\rm rd}$ St Pump Assisted Injection Well Stormwater Utility design services, the proposals are hereby ranked by the City Commission as follows:

- (1) Jacobs Engineering Group, Inc.
- (2) BCC Engineering, LLC.

Section 2: That the City Manager is authorized to negotiate a contract with Jacobs Engineering Group, Inc., as the highest-ranked respondent, upon advice and consent of the City Attorney.

Section 3: The project will be funded from stormwater fund Construction In Progress account 402-3802-538-6500 (Project ST38022201 Fogarty and 3rd Pump Assisted Injection Well).

Section 4: That the contract, including cost proposal, to complete the scope of work for FOGARTY & 3^{RD} ST PUMP ASSISTED INJECTION WELL stormwater utility project, will be brought to the City Commission for final approval. Section 5: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
