**A RESOLUTION OF THE CITY COMMISSION OF
THE CITY OF KEY WEST, FLORIDA, ACCEPTING
THE ARTS AND CULTURE MASTER PLAN FOR
TRUMAN WATERFRONT PARK; DIRECTING CITY
STAFF TO WORK TOWARD IMPLEMENTING "STEP
1" RECOMMENDATIONS CONTAINED THEREIN;
PROVIDING FOR AN EFFECTIVE DATE**

WHEREAS, in Resolution 18-234, the City Commission contracted Civic Moxie to furnish an Arts and Culture Master Plan for Truman Waterfront; and

WHEREAS, after public meetings and a detailed analysis, Civic Moxie has completed the Arts and Culture Master Plan for Truman Waterfront, offering numerous recommendations to make the space more active and welcoming, with community programs for people of all ages and backgrounds; and

WHEREAS, the City Commission desires to move forward with the actions contained in Step 1 of the Arts and Culture Master Plan for Truman Waterfront.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the City Commission hereby accepts the attached Arts and Culture Master Plan for Truman Waterfront.

Section 2: That City staff is directed to work toward implementing the Phase I recommendations contained in the Arts and Culture Master Plan for Truman Waterfront, which are attached hereto.

Section 3: That the Parks and Recreation Advisory Board shall provide an annual Truman Waterfront Arts and Cultural Action Plan as part of its Annual Report, summarizing accomplishments as well as future plans;

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
