1. Substitute 'Finding the 287(g) voluntary memorandum of agreement with ICE to be void and unenforceable' in place of terminating said agreement.

2. Section 1 to be completely struck and replaced with, 'The Chief of Police did not have authority to execute the 287(g) agreement, and the City Commission considers the 287(g) agreement signed by the Chief of Police of the City of Key West, Sean Brandenburg on March 4, 2025, void and unenforceable. The City Manager is hereby directed to immediately suspend all activities, training and operations associated with the 287(g) agreement and cease the allocation of city resources. The City Manager, upon consent of the City Attorney, shall provide notice to ICE and any other relevant entities, that the City is suspending all involvement in the 287(g) related activities due to the current agreement being unenforceable and without legal effect.'
