A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING WALKER INTERNATIONAL EVENTS, INC. THE USE OF THE SOUTH WEST CORNER FIELD OF THE TRUMAN WATERFRONT FOR A SMALL FAMILY CIRCUS WITH SHOWTIMES ON THURSDAY, JANUARY 23, AND FRIDAY, JANUARY 24, 2014 AT 5:30 & 7:30 PM; AND SATURDAY, JANUARY 25, 2014 AT 3:00 & 5:30 PM AND SUNDAY JANUARY 26, 2014 AT 2:00 & 4:30 PM; GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES DURING THE EVENT; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Walker International Events, Inc wishes to use the Truman Waterfront along the East Quay Wall for a small family circus on January 23 through January 26, 2014; and

NOW THEREFORE, BE IT RESOLVED, by the City Commission of the City of Key West, Florida;

SECTION 1. That the Walker International Events, Inc is hereby granted permission to use the Truman Waterfront during the hours stated above; PROVIDED all trash is adequately collected and contained; guarantee indemnifying the City is executed; and provided the organizations meet the terms and conditions set forth by the City Manager; and that 25% of gross revenue or \$1,000.00, whichever is greater, shall be donated to Police Benevolent Association.

SECTION 2. That any use of the Truman Waterfront properties should be coordinated and approved through the Local Redevelopment Agency Office.

SECTION 3. That prior to the use of the Truman Waterfront, Walker International Events, Inc. must provide a \$1000.00 refundable deposit and a \$500.00 non-refundable payment for use of the property.

SECTION 4. That Walker International Events, Inc. is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place and time herein described.

SECTION 5. That the Walker International Event, Inc. will adhere to the recycling plan of the City of Key West, and that one(1) recycling container for every one (1) trash barrels will be used and that they will be place side by side.

SECTION 6. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
