**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING SHOOT FOR THE MOON TO CONDUCT A BATTLE IN THE BAY DRAGON BOAT FESTIVAL AT THE TRUMAN WATERFRONT ON SATURDAY, MAY 11, 2013, FROM 6:00 A.M. TO 7:00 P.M; ( PRACTICE SESSION MAY 10, 2013); PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN AN ENCLOSED AREA; GRANTING AN EXEMPTION FROM THE NOISE CONTROL ORDINANCE PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCE FROM 6:00 A.M. TO 7:00 P.M; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, Shoot for the Moon Battle in the Bay Dragon Boat Festival wishes to conduct Dragon Boat Festival at Truman Waterfront between the hours of 6:00 a.m. to 7:00 p.m. on Saturday, May 11, 2013; and

**WHEREAS**, this event shall take place on the grounds of the Truman Waterfront between the hours of 6:00 a.m. to 7:00 p.m. on May 11, 2013; and

**WHEREAS**, the sponsors anticipates that amplified music will be played during the event;

**NOW THEREFORE, BE IT RESOLVED**, by the City Commission of the City of Key West, Florida;

**SECTION 1.** That Shoot for the Moon Battle in the Bay Dragon Boat Festival is hereby granted permission to conduct their “Battle in the Bay Races” on the date and during the hours stated above; **PROVIDED** all trash is adequately collected and contained; that a guarantee indemnifying the City is executed; that the organization meet the terms and conditions set forth by the City Manager; and that 25% of gross revenue or \$1,000.00, whichever is greater, shall be donated to Reef Relief.

**SECTION 2.** That pursuant to Section 18-86 of the Key West Code of Ordinances, Shoot for the Moon Battle in the Bay Dragon Boat Festival is hereby granted permission allowing the sale and consumption of alcoholic beverages within an enclosed area.

**SECTION 3.** That Shoot for the Moon Battle in the Bay Dragon Boat Parade is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place at the place and time herein described.

**SECTION 4.** That any use of the Truman Waterfront properties should be coordinated and approved through the Local Redevelopment Agency Office.

**SECTION 6.** Shoot for the Moon Battle in the Bay Dragon Boat Festival will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used that that they will be placed side by side.

**SECTION 7.** That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
