A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA APPROVING TASK ORDER NO. 3-17-SWR FROM CH2M HILL ENGINEERING, INC. IN AN AMOUNT NOT TO EXCEED \$271,600.00 FOR WASTEWATER COLLECTION SYSTEM G.I.S. (GEOGRAPHIC INFORMATION SYSTEM) DATABASE DEVELOPMENT; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 12-280, the City Commission approved a contract with CH2M Hill, Inc. for General Engineering Services and in Resolution 15-208 the contract was renewed for a two-year term; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That Task Order No. 3-17-SWR for CH2M Hill Engineering, Inc. for Wastewater Collection System G.I.S. Database Development is hereby approved in an amount not to exceed \$271,600.00.

Section 2: That adequate funds are already allocated to FY 17 sewer funds in cost center 401-3503-535.3100.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
