A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING A WORK ORDER UNDER THE CITY'S RIGHT-OF-WAY IMPROVEMENT CONTRACT WITH CHARLEY TOPPINO & SONS, INC. IN A TOTAL AMOUNT NOT TO EXCEED \$122,328.93 FOR ANGELA STREET IMPROVEMENTS FROM EMMA STREET TO THOMAS STREET INCLUDING AMERICANS WITH DISABILITIES ACT (ADA) ACCESS IMPROVEMENTS; AUTHORIZING NECESSARY BUDGET TRANSFERS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 17-106, the City Commission approved a Right-of-Way Improvements contract with Charley Toppino & Sons, Inc. and in Resolution 19-053 the contract was extended for an additional year; and

WHEREAS, City staff recommends approval of a Work Order to create an ADA compliant access route for bicycle, pedestrian and one-way vehicular traffic on Angela Street between Truman Waterfront Park and Bahama Village; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the attached Work Order under the City's Right-of-Way Improvement Contract with Charley Toppino & Sons, Inc. in a total amount not to exceed \$122,328.93, for Angela Street improvements, including Americans with Disabilities Act access, from Emma Street to Thomas Street, is hereby approved.

Section 2: That funding is budgeted for right of way improvements in account 102-4102-541-6300, Project Number I141021801 ADA Compliant Sidewalks, and any necessary budget transfers are hereby approved.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
