A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING MILE 0 EVENTS TO HOLD THE FANTASY FEST 5K ON MONDAY, OCTOBER 20, 2025, FROM 6:00 P.M. TO 8:00 P.M. (SET-UP STARTING AT 4:00 P.M.) BEGINNING AT IRISH KEVIN'S - 211 DUVAL STREET; AUTHORIZING THE CLOSURE OF CERTAIN STREETS OR PORTIONS THEREOF FOR SAID RACE FROM 4:00 P.M. TO 8:00 P.M.; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, The Mile 0 Events wishes to conduct the "Fantasy Fest 5K" beginning and ending at Irish Kevin's - 211 Duval Street during the hours of 6:00 p.m. to 8:00 p.m. (Set-up starting at 4:00 p.m.) on Monday, October 20, 2025; and

BE IT RESOLVED by the City Commission of the City of Key West, Florida, as follows:

**SECTION 1.** That in Resolution 19-174, the City Commission directed the City Manager to "develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the local government for the provision of good or services, unless such use is otherwise preempted by law."

**SECTION 2.** "That the vendor/lessee/licensee acknowledges the

City's concern about the negative environmental impact of using disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/Lessee/licensee/contractor therefore commits to refrain from the use of polystyrene/plastic straws, bags, plastic utensils and "To go" packages for food or products sold on any property leased from the City."

**SECTION 3.** That Mile 0 Events is hereby granted permission to hold the "Fantasy Fest 5K" starting and ending at Irish Kevin's - 211 Duval Street on Monday, October 20, 2025, from 6:00 p.m. to 8:00 p.m.; PROVIDED all trash is adequately collected and contained; guarantee indemnifying the City is executed; and provided the organizations meet the terms and conditions set forth by the City Manager.

**SECTION 4.** That Mile 0 Events is hereby granted permission for the closure of certain streets throughout the city for the "Fantasy Fest 5K" on the date and during the hours stated above.

**SECTION 5.** That Mile 0 Events will adhere to the recycling plan of the City of Key West, that one (1) recycling container for everyone (1) trash barrels will be used and that they will be placed side by side.

**SECTION 6.** That Mile 0 Events acknowledges that they

are responsible for payment to the Key West Police Department,  
the Key West Fire Department and Community Services.

**SECTION 7.** That Mile 0 Events will make a donation to Reef Relief.

**SECTION 8.** That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officers and Clerk of the Commission.
