**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING MR. Z'S TO CONDUCT A BLOCK PARTY FUNDRAISER FOR THE WESLEY HOUSE ON SUNDAY, APRIL 1, 2012 STARTING AT 12:00 NOON TO 4:00 P.M.; AUTHORIZING THE CLOSURE OF THE 500 BLOCK OF SOUTHARD STREET BETWEEN DUVAL STREET & BAHAMA STREETS; AUTHORIZING THE COMSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE BARRICADED AREA OF THE EVENT; GRANTING AN EXEMPTION FROM THE NOISE CONTROL ORDINANCES PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES DURING THE EVENT; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS,** Mr. Z's and the Wesley House have applied to the City for a Special Event Permit as a fundraiser for the Wesley House on Sunday, April 1, 2012 from 12:00 noon to 4:00 p.m.

**NOW, THEREFORE, BE IT RESOLVED** by the City Commission of the City of Key West Florida;

**SECTION 1.** That Mr. Z's and the Wesley House is hereby granted permission to conduct a "Fundraiser for Wesley House" on the 500 block of Duval Street between Duval & Bahama Streets on the day and during the hours stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; and that the organization meets the terms and conditions set forth by the City Manager.

**SECTION 2.** That pursuant to Section 18-86 of the Key West Code of Ordinances, Mr. Z's & the Wesley House are hereby granted permission allowing the sale and consumption of alcoholic beverages within the enclosed area.

**SECTION 3.** That Mr. Z's and the Wesley House are hereby granted a Special Event Permit under Section 6-86 of the Key West of Ordinances for an event that will take place and

time herein described.

**SECTION 4.** That Mr. Z's & the Wesley House will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

**SECTION 5.** That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and the Clerk of the Commission.
