A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE COMMITTEE RANKING AND AWARDED A CONTRACT FOR MEDICAL DIRECTOR OF EMS IN RESPONSE TO RFP NO. 012-018; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND EXECUTE A CONTRACT IN CONFORMANCE WITH THE TERMS AND CONDITIONS CONTAINED IN RFP 12-018 UPON THE ADVICE AND CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City issued Request for Proposals No. 012-18 on August 22, 2018 for Medical Director of EMS; and

WHEREAS, of the three firms that responded, it was determined that all of the proposals were responsive to the RFP; and

WHEREAS, a committee comprised of City staff and local experts convened at a properly noticed meeting conducted consistent with the "Sunshine Law," on October 1, 2018, and ranked the responsive proposals upon specific criteria; and

WHEREAS, City staff recommends City Commission approval of the ranking and award of a contract, in accordance with the Committee recommendation.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the proposals for Medical Director of EMS are hereby ranked and approved by the City Commission as follows:

- (1) Dr. Guerdan
- (2) Dr. Gandia
- (3) Dr. Partrick/Blass

Section 2: That the City Manager or his designee is hereby authorized to negotiate a contract with the first ranked firm. Should the City Manager be unable to negotiate an acceptable contract with the first ranked firm, he shall discontinue negotiations and commence negotiations with the second ranked firm. Should the City Manager be unable to negotiate an acceptable contract with the second ranked firm, he shall discontinue negotiations and commence negotiations with the third ranked firm. If an acceptable contract is not negotiated, the City Manager will report back to the City Commission.

Section 3: Upon completion of successful negotiations, the City Manager is authorized to execute contract upon the advice and consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
