A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RANKING PROPOSALS RECEIVED IN RESPONSE TO RFP #09-015, FOR MONITORING OF DEBRIS REMOVAL AND RELATED SERVICES; AUTHORIZING THE NEGOTIATION OF CONTRACTS WITH THE THREE TOP-RANKED PROPOSERS; AUTHORIZING THE CITY MANAGER TO ENTER INTO CONTRACTS IN SUBSTANTIAL CONFORMANCE WITH THE BID DOCUMENTS, UPON ADVICE OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City received three proposals in response to Request for Proposals No. 09-015, for monitoring of debris removal and related services; and

WHEREAS, all three proposals were deemed by the evaluation committee to be responsive to the RFP; and

WHEREAS, at a public meeting on November 18, 2015, the evaluation committee ranked the responsive proposals, and recommended establishing pre-approved contracts with the three firms;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the proposals for professional services for monitoring of debris removal and related services are hereby ranked by the evaluation committee and approved by the City Commission as follows:

- (1) Tetra Tech, Inc.
- (2) True North Emergency Management, LLC
- (3) Witt O'Brien's, LLC

Section 2: That the City Manager is hereby authorized to negotiate and execute contracts with the three companies in order of ranking, upon advice and consent of the City Attorney, in substantial conformance with the draft Agreement contained in the RFP package.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
