RESOLUTION NO. 23-337

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE RANKING OF RESPONSES TO THE REQUEST FOR QUALIFICATIONS (RFQ) NO. 24-001 BY THE SELECTION COMMITTEE FOR THE KEY WEST WATERSHED MANAGEMENT PLAN; AUTHORIZING THE CITY MANAGER AND CITY NEGOTIATE AND EXECUTE A ATTORNEY TO CONTRACT NOT TO EXCEED \$184,818.75 WITH THE HIGHEST RANKED TEAM, ERIN DEADY, P.A.; APPROVING ANY NECESSARY AMENDMENTS AND TRANSFERS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in Resolution 23-188, the City Commission approved the "Federally Funded Subaward and Grant Agreement" with the Division of Emergency Management for Project Number 4337-4-Po/Agreement #Ho866, accepting a total amount up to \$184,818.75 toward the Key West Watershed Management Plan; and

WHEREAS, the City issued a Request for Qualifications (RFQ) No.24-001 to identify a vendor to provide a Watershed Management Plan, in accordance with FEMA CRS Guidelines for the purpose of achieving a Class 4 flood insurance discount for the community; and

WHEREAS, RFQ 24-001 outlines the professional services required to complete this project, and includes a draft contract with a scope of work and deliverables to achieve a CRS-compliant Watershed Management Plan; and

WHEREAS, on November 1, 2023, the City Clerk opened vendor submittals, one of which was deemed responsive; and

WHEREAS, on November 15, 2023, a Selection/Ranking Committee comprised of City staff scored the RFQ submittal; and determined Erin Deady, P.A. be the highest-ranked proposer with an average of 90 out of 100 possible points.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the vendor submittal for RFQ No.24-001 for the Key West Watershed Management Plan is hereby ranked by the City Commission as follows:

(1) Erin Deady, P.A., 90 points.

Section 2: That the City Manager is authorized to negotiate and execute a contractual agreement not to exceed \$184,818.75 with the top- ranked vendor, Erin Deady, P.A., in substantial conformance with the RFQ, and as legally permissible pursuant to the City Charter, upon advice and consent of the City Attorney.

Section 3: That this contract will be funded from 108 3806 538 3100 (Adaptation/Professional Services), and any necessary budget adjustments are hereby authorized.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication

by the signature of the Presiding Officer and the Clerk of the Commission.
