





NARRATIVE OF INCIDENT

Officers responded to 1327 Simonton Street (Rooster Treats) in reference to a trespasser who refused to leave the property. Upon arrival, Officers met with the subject, who refused to provide any identifying information and refused to listen to officers' commands to leave the property. While subject was laying down, he exposed his penis, began to urinate and scream threats to the officers. Officers attempted to detain and gain control of the subject, however, he began to actively resist by pulling away from officers and failed to place his hands behind his back. Officer Beerbower delivered three (3) hand strikes to the subjects' right shoulder at which time the officers were able to place the subject into handcuffs. Subject sustained minor lacerations in the struggle.
