AN ORDINANCE OF THE CITY OF KEY WEST, FLORIDA, AMENDING CHAPTER 2 OF THE CODE OF ORDINANCES ENTITLED "ADMINISTRATION" BY AMENDING SECTION 2-32 TO PROVIDE FOR SALARY ADJUSTMENTS FOR THE MAYOR AND CITY COMMISSIONERS; PROVIDING FOR SEVERABILITY; PROVIDING FOR REPEAL OF INCONSISTENT PROVISIONS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Key West City Commission finds that the salaries of elected officials in the City of Key West require periodic adjustment; and

WHEREAS, the Key West City Commission finds that regulations amending the compensation regulations for elected officials would serve to promote the health, safety and welfare of the citizens of Key West;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF KEY WEST, FLORIDA:

Section 1: That Chapter 2 of the Code of Ordinances is hereby amended as follows*:

Sec. 2-32. Salaries of mayor, commissioners.

(a) As used in this section, the term "salary" shall mean total compensation paid by the city as personal income.

(b) The mayor shall receive an annual salary of \$10,000.00 as set forth below:.

FY 2010-11	\$10,000.00 per year	
FY 2011-12	\$13,125.00 per year	
FY 2012-13	\$16,250.00 per year	
FY 2013-14	\$19,375.00 per year	
FY 2014-15 and thereafter	\$22,500.00 per year	
(c) Each city commissioner shall receive an annual salary		
of \$8,500.00 as set forth below:.		
FY 2010-11	\$8,500.00 per year	

FY 2011-12 \$11,375.00 per year

FY 2012-13 \$14,250.00 per year

FY 2013-14 \$17,125.00 per year

FY 2014-15 and thereafter \$20,000.00 per year

Section 2: If any section, provision, clause, phrase, or application of this Ordinance is held invalid or unconstitutional for any reason by any court of competent jurisdiction, the

remaining provisions of this Ordinance shall be deemed severable therefrom and shall be construed as reasonable and necessary to achieve the lawful purposes of this Ordinance.

Section 3: All Ordinances or parts of Ordinances of said
City in conflict with the provisions of this Ordinance are hereby
superseded to the extent of such conflict.

Section 4: This Ordinance shall become effective on the date of the commencement of the terms of the mayor and commission elected at the next regular election, in accordance with City Charter provision 3.03, and authentication by the signature of the presiding officer and the Clerk of the Commission.
