Comments:

On 06052025 at approximately 0047 Hours, I was dispatched to the area of 900 Simonton St in regard to a suspicious person.

Upon my arrival, I met with Victoria L. Rowden, a white female, born on 02/22/1968 who stated the male broke a window and left east on Olivia St, and that Officer J. Young was in contact. I then told her that I would return and exited to assist Officer Young. As I traveled east on Olivia I located Officer Young in a foot pursuit north on Elizabeth from Olivia. I exited my marked patrol vehicle and assisted. As I arrived, Officer Young had the party later identified as Brandon L. Straitiff on the ground. Straitiff was still actively resisting arrest at this point. Straitiff was attempting to conceal his hands under his body, I delivered 3 knee strikes to his left side in an attempt to gain positive control of his left arm. As the strikes were unsuccessful, I informed Straitiff that he would be Tazed if he did not present his hands. He continued to refuse, I then used the Drive stun technique between Straitiff shoulder blades, this proved to be ineffective as Straitiff just giggled. I relocated to his lower left side, and this also proved to be ineffective. I holstered my

Taser and began to use physical force and joint manipulation to secure his arm which was effective. Straitiff was placed into handcuffs which were checked for proper fit and double locked. He was then moved to Ofc. Young's marked patrol vehicle where a search incident to arrest was conducted. It should be noted that Straitiff continued to resist this entire time by trying to pull away. While trying to place him in the patrol vehicle he continued to resist refusing to get in. While trying to place him in Straitiff spit in my face. EMS responded to check on him due to the Taser deployment which resulted in transport to the Lower Keys Medical Hospital for evaluation. Once cleared Straitiff was placed in my patrol vehicle where he continued to resist headbutting me in the process. He was then transported to the Monroe County jail for booking.

Upon returning to 900 Simonton St. (Bobby's Monkey bar) Mrs. Rowden stated the following. Straitiff entered the bar and tried to speak to 2 females that were sitting at the front bar. When they were unresponsive to him he became angry and began to insult them. Rowden then told Straitiff to leave, In response Straitiff spit in Rowden's face landing on the right cheek. He then exited the bar. Upon exiting he turned and punched the front door breaking the glass. Rowden estimated the damage to be valued at 300.00 dollars.

Rowden wished to aid in prosecution. She was later provided a Victim's Rights Brochure

In a Criminal history search of Straitiff, the following convictions were identified.

08-22-2017 Assault (misdemeanor) Guilty, Court Case CR-2017-0008633 ID 6th District court

12-04-2019 Assault (Felony) Guilty, Court Case Cr18-11212 ID 6th District court

Based on the facts and evidence, I believe there is probable cause that on 06/05/2025, Brandon L. Straitiff did knowingly and intentionally violate F.S.S. 784.03 Battery, by actually and purposefully spitting in the face of Victoria L Rowden, against her will, placing her in fear of bodily harm.

Based on the facts and evidence, I believe there is probable cause that on 06/05/2025, Brandon L. Straitiff did knowingly and intentionally violate F.S.S. 784.07-2B Battery on LEO, by actually and intentionally spitting in my face and headbutting me, while I was engaged in my legal, lawful duties as a uniformed law enforcement officer.

Based on the facts and evidence, I believe there is probable cause that on 06/05/2025, Brandon L. Straitiff did knowingly and intentionally violate F.S.S. 843.01 Resisting with Violence, by actually and purposely initiating a physical altercation with officers by kicking, striking, and spitting all while we were engaged in our legal, lawful duties as uniformed law enforcement officers.

Based on the facts and evidence, I believe there is probable cause that on 06/05/2025, Brandon L. Straitiff did knowingly and intentionally violate F.S.S. 843.02 Resisting without Violence, by actually and purposely fleeing on foot from Officer Young while he was engaged in his legal, lawful duties as uniformed law enforcement officers.

Based on the facts and evidence, I believe there is probable cause that on 06/05/2025, Brandon L. Straitiff did knowingly and intentionally violate F.S.S. 806.14 Criminal Mischief, by willfully and maliciously damaging the property of Bobby's Monkey Bar when he broke the front window.

Based on the facts and evidence, I believe there is probable cause that on 06/05/2025, Brandon L. Straitiff did knowingly and intentionally violate F.S.S. 775.13 FAIL TO REGISTER; CONVICTED FELON, by failing to register within 48 hours after entering Monroe County in this state.
