On 02/05/2025 at approximately 2218 hours I, Ofc. M. Beerbower (2259) responded to 1327 Simonton St (Rooster Treats) regarding a report of trespassing.

Upon arrival, Ofc. I. Golovanov and Ofc. A. Burns were already on-scene attempting to speak to John Prenes Dantzler (07/27/1978) who was lying on the ground on his left side, with his left arm and hand concealed under him, behind the ice cream shop. I asked Dantzler what his name was and he responded, "Fuck You!" and "Fuck You Bitch!"

Ofc. I. Golovanov went to speak with the manager of the store, Nataliya Ilchenko (03/13/1983) who stated that she wished for Dantzler to leave the property and to have a trespass warning issued to him for the business and the property.

Note: While Ofc. Golovanov was speaking to Ilchenko, Dantzler continued to refuse to identify himself. At one point, Dantzler pulled his penis from his pants with his right hand and began to urinate on the ground and on himself while still lying on his left side.

Ofc. Golovanov returned to where I was standing and informed me of Ilchenko's request to have Dantzler trespassed from the property. I told Dantzler that he was trespassed from the property and that he would have to leave. Dantzler responded, "Fuck You". I asked Dantzler to stand up, gather his belongings and leave. Dantzler responded, "Fuck You".

At that point I told Dantzler that he was under arrest for trespassing and ordered him to stand up and place his hands behind his back. Dantzler again responded, "Fuck You!". Ofc. A. Burns and I attempted to place Dantzler's hands behind his back. Dantzler rolled to his left, attempting to lie on his stomach. He simultaneously attempted to draw both of his arms underneath of him, resisting our efforts to take him into custody. Officer burns and I were able to secure Dantzler's right arm and place his right hand into handcuffs. Dantzler's left arm remained under him, and he refused to place it behind him. Despite Ofc Burns and my efforts, we were unable to retrieve Dantzlers left arm and subsequently were unable to tell if he was holding anything in his left hand. I delivered three to four hand strikes to Dantzler's Suprascapular nerve in order to take control of his left arm. The strikes were effective and Ofc. Burns and I were able to secure Dantzler's left arm and hand and place him handcuffs.

After being placed into handcuffs, Dantzler continued to resist efforts to effect his arrest by posturing his body in a stiff manner and throwing his legs out. Dantzler's actions were such that a leg restraint device was needed to secure his feet together before being placed into the back of my patrol vehicle.

I began to transport Dantzler to the Monroe County Detention Center. During transport, I asked Dantzler to identify himself again and he responded, "Fuck You, Bitch". Dantzler then stated multiple times that I was dead and that he was going to kill me.

Upon arrival at the MCDC, Dantzler became agitated again and repeated his threat that he was going to kill me. To ensure my safety and Dantzler's safety, I requested another officer to assist me in walking Dantzler to the elevator and ultimately upstairs to the intake area of the jail. Ofc. S. Adorno responded and assisted me in that endeavor.

Once upstairs, Dantzler still refused to identify himself. After several requests, he shouted "John Prenes Dantzler!". Dantzler was asked to provide his date of birth. Dantzler answered, "Fuck You".

Dantzler then refused to answer any medical questions by the MCDC medical professional. Dantzler's actions were such that MCSO deputies were unable to immediately process him into the jail. MCSO deputies kept Dantzler in

handcuffs and placed him into a temporary holding cell until he was calm enough to be processed.

Once Dantzler was secured in the temporary holding cell, MSCO Deputies were able to conduct a search of Dantzler's first and last name in their data base and successfully identified him (to include his photo). A search through F/NCIC revealed that Dantzler is a known Gang member, affiliated with "The Crips" (FBI Number 925428cb1)

Given the above facts and evidence, I found probable cause to charge Dantzler with the following:

One (1) count of Trespassing:

Contrary to F.S.S. 810.09, John Prenes Dantzler did, without being authorized, licensed, or invited, willfully enter upon or remain on the property of Rooster Treats at 1327 Simonton St. and refused to leave after being warned to do so.

One (1) count of Resisting Arrest Without Violence:

Contrary to F.S.S. 843.02, John Prenes Dantzler did resist, obstruct, or oppose KWPD police officers in full uniform as defined in Fl statute, without offering or doing violence to the officers by refusing to identify himself and by refusing lawful commands for him to place his hands behind his back after being told he was under arrest.

One (1) count of Threatening a Law Enforcement Officer:

Contrary to F.S.S. 836.12(2)(a), John Prenes Dantzler did knowingly and willfully threaten a law enforcement officer with death or serious bodily harm by stating that he was going to kill me multiple times while being transported to the Monroe County Detention Center.

My AXON BWC was activated and uploaded to Evidence.com.

My AXON rear-facing camera was activated during transport to the MCDC and uploaded to Evidence.com.

On 02/06/2025 at approximately 2215 hours, multiple officers and I, Officer Golovanov, were dispatched to 1321 Simonton Street in reference to a black male who was on the ground and screaming behind an ice cream truck incident.

Upon arrival, we located the subject (John P. Dantzler, DOB: 07/27/1978) sleeping in the sand behind the ice cream truck. The truck's employee wanted John to leave the property.

When we tried to wake up John, he immediately became belligerent, started yelling at us and saying "Fuck You!" to any question we asked him. John was informed that he needed to leave the property immediately. John continued to act belligerently toward us and disobeyed any of our lawful orders.

John, who was in a prone position, continued to resist while we were attempting to handcuff him. John refused to place his left hand behind his back. When John began to kick, I gave him loud verbal commands to stop fighting. John continued to kick, so I had to apply a hobble on his ankles to prevent any injuries to the officers.

John repeatedly disobeyed our lawful orders, so Lieutenant Stockton and I grabbed him by the armpits and dragged him to Officer Beerbower's patrol vehicle. I searched John, and we were able to place him in the back of the patrol vehicle.

On February 5, 2025, at approximately 2205 hours, I (Ofc. A. Burns) responded to Southwinds Motel (1321 Simonton Street), in reference to a black male trespassing.

Upon arrival, Ofc. I. Golovanov and I located the black male behind Rooster Treats (1327 Simonton Street), lying on his left side in the sand. The male was later identified as John P. Dantzler. Ofc. M. Beerbower was shortly on scene.

While attempting to converse with Dantzler he would consistently respond with, "Fuck you." While attempting to ask Dantzler questions he would refuse to answer questions. Throughout the interaction Dantzler would respond with numerous, "Fuck you." Dantzler became belligerent and yelled obscenities such as, "Fuck you bitch."

Ofc. Beerbower informed Dantzler he was trespassing and needed to leave the property. Dantzler refused and stated, "Fuck you." Ofc. Beerbower informed Dantzler he was under arrest. I attempted to place handcuffs onto Dantzler. I was able to get one handcuff onto his right wrist while Dantzler's left arm was beneath his body. Dantzler was given multiple lawful orders to place his left arm behind his back. Once Dantzler's left arm was placed behind his back, I was able to place his left wrist into the other handcuff. Once Dantzler was placed into handcuffs he began resisting by "wiggling" around in the sand.

I assisted in searching Dantzler's belongings.

My BWC (4352) was activated for this incident and uploaded to Evidence.com.
