A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA APPROVING THE WORK ORDERS FOR CHARLEY TOPPINIO & SONS, INC. IN THE AMOUNT OF \$1,511,105.97 FOR ASPHALT MILLING AND PAVING, STRIPING, AND SHOULDER REPAIR UNDER THE RIGHT- OF-WAY IMPROVEMENTS CONTRACT; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY BUDGET TRANSFERS OR AMENDMENTS, UPON CONSENT OF THE CITY ATTORNEY'S OFFICE; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Resolution No. 22-289 approved the award of a right-of-way improvements contract with Charley Toppino & Sons, Inc. for construction work including roadway milling and paving, striping, and shoulder repair which was renewed for one year by Resolution No. 25-061; and

WHEREAS, the City currently monitors roadway conditions to develop a prioritized list of City streets in need of repair and maintenance which are then ranked based on conditions and evaluated for traffic loading and average daily traffic, and

WHEREAS, staff have requested and received the attached work order for roadway improvements based on aforementioned condition assessments in the amount of \$1,511,105.97; and

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached work order in the amount of \$1,511,105.97 under the contract awarded to Charley Toppino & Sons, Inc. in resolutions 22-289 and 25-061 is approved.

<u>Section 2</u>: That the City manager is authorized to execute documents related to this work order, upon the advice and consent of the City Attorney's office.

Section 3: That the funds for the work order are allocated in account no: 102-4102-541-6300. Any necessary budget transfers or amendments are hereby authorized.

Section 4: That this resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
