A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA APPROVING A COST INCREASE OF \$18,343.00 FOR THE PURCHASE OF THE NEW 2023 MXP170 AMBULANCE (ON A 2024 FORD F-450 GAS CHASSIS), PREVIOUSLY AUTHORIZED UNDER RESOLUTION 22-140, FOR THE NEW TOTAL PURCHASE PRICE OF \$264,080.00; AUTHORIZING THE CITY MANAGER TO EXECUTE A CHANGE ORDER IN THE COST INCREASE AMOUNT OF \$18,343.00 TO BE PAID FROM INFRASTRUCTURE/SURTAX/EMS ACCOUNT #101-2601-526-6400; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, on June 21, 2022, via Resolution 22-140, the City of Key West authorized the purchase of a new 2023 Demers ambulance (on a 2024 Ford gas chassis) in an amount not to exceed \$245,737.00; and

WHEREAS, due to national manufacturing and chassis delays and shortages, the production time from build to delivery exceeded thirty months; and

WHEREAS, equipment design options became available since the apparatus was originally designed in 2022 and the delay in manufacturing allowed KWFD to have the ambulances painted and with graphics that match the current fleet; and

WHEREAS, the \$18,343.00 cost increase will be paid from Infrastructure/Surtax/EMS Account 101-2601-526-6400; and

WHEREAS, the City Manager's Office hereby requests the City Commission approve the \$18,343.00 cost increase to purchase the new 2023 MXP170 Ambulance Demers ambulance previously authorized by Resolution 22-240, bringing the total purchase price to \$264,080.00;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the City Commission hereby approves the \$18,343.00 cost increase to purchase the 2023 MXP170 Ambulance, previously authorized under Resolution 22-140, for the new total purchase price not to exceed \$264,080.00.

Section 2: That the City Manager is hereby authorized to execute a Change Order for the purchase cost increase amount of \$18,343.00 to be paid from Infrastructure/Surtax/EMS Account 101-2601-526-6400.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
