A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, TERMINATING THE AGREEMENT BETWEEN THE CITY OF KEY WEST AND KCI TECHNOLOGIES, INC. FOR DUVAL STREET REVITALIZATION PLAN, PURSUANT TO SECTION 7.2. OF THE AGREEMENT; AUTHORIZING FINAL PAYMENT FOR SERVICES RENDERED, UPON PROVISION OF PROJECT DOCUMENTS SPECIFIED IN SECTION 7.1 OF THE AGREEMENT; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution 20-164 the City Commission ranked and awarded the bid of KCI Technologies, Inc. in response to RFQ #20-001 for Duval Street Revitalization Plan, and authorized the City Manager to negotiate and execute a contract; and

WHEREAS, the City Commission finds that KCI Technologies has promulgated changes to staffing and approach to the project that are not in the best interests of the City of Key West; and

WHEREAS, section 7.2.1 of the Agreement specifies that the Agreement may be terminated with or without cause by City at any time, and accordingly, city staff recommends immediate termination; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the City Commission hereby terminates the contract between the City of Key West and KCI Technologies, Inc. for Duval Street Revitalization (RFQ 20-001), effective immediately.

Section 2: That final payment is authorized for services provided up to this effective date, upon provision of all project related documents to the City, as specified in Section 7.1 of the Agreement between the City and KCI Technologies.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
