# **1. UNDERSTANDING OF WORK**

### **SCOPE OF SERVICES**

It is our understanding that the City of Key West is seeking an engineering firm to provide professional design, engineering, and construction management services to the City for Safe Routes to School sidewalks located along Duck Avenue. The project is to provide sidewalks that will enhance the safety of both pedestrian and bicycle traffic along Duck Avenue, from Glynn Archer Drive (14th Street) to 17th Street, and 12<sup>th</sup> Street, from Staples Avenue to Seidenberg Avenue in order to provide safe bicycle and pedestrian access routes to Poinciana Elementary School. These enhancements will improve the safety of children going to school at Poinciana Elementary School. The project includes the development of a bid package, contract agreement and FDOT requirement forms, conditions of the contract, and construction specifications and plans for the installation of the required sidewalks.

It is anticipated that the scope of services for this project will include, but are not limited, to:

- Preparation of preliminary design reports and associated project cost estimates.
- Meetings and presentations before community groups and City of Key West Staff
- Preparation of construction plans, technical specifications and supplementary conditions for the Safe Routes to School *Poinciana Elementary School Sidewalk Installation* project.
- Preparation of Opinions of Probable Construction Cost.
- Preparation of requested studies and or engineers letters of opinion
- Preparation of all required submittal packages as required for agency approvals (i.e. Federal, State, County, and City).
- Bid Phase services including responding to bidders' questions, issuance of addenda, bid review, reference checks, and recommendation for award.
- Construction Phase Services including conducting preconstruction and periodic meetings, routine
  or periodic site visits, inspections, review of payment applications, responding to Requests for
  Information from the contractor, certification of substantial and/or final completion.

It is understood that time is of the essence for the Safe Routes to School sidewalks along Duck Avenue pursuant to the Request for Qualifications dated February, 2011. It is our understanding that in accordance with the Local Agency Program (LAP) Agreement, 60% complete design and construction plans and specification documents for the Duck Avenue and 12th Street project shall be completed by June 30, 2011, and that final construction design and specification documents shall be completed by August 20, 2011. The Corradino Group, Inc. (Corradino) has assembled an experienced team inclusive of a local Key West company to ensure that the work is efficiently and effectively completed. Our Subconsultant Perez Engineering & Development, Inc. (PE&D) not only has their place of business located in the City of Key West, but PE&D and Corradino have all have worked successfully for the City of Key West in the past. Corradino has successfully executed similar projects in both size and scope for the City of Key West and has assembled the resources necessary to execute this project in the time frame required.

### **TECHNICAL APPROACH**

#### PRELIMINARY DESIGN REPORTS

Upon the receipt of the Notice to Proceed (NTP), an initial review of all existing conditions will be conducted. It is anticipated that this information, in addition to both a boundary and topographical

survey, may include existing surveys, as-built and record drawings, existing lighting and vault layouts, and existing utility information. Once this information has been reviewed by the Corradino Project Manager (PM) and other key Corradino team members, staff-meetings will be held with the City staff to review preliminary phasing alternatives and establish required representation from each stakeholder group, local residents, and City staff so that open dialog can identify project needs and constraints.

We understand that at least one, if not more, community meetings chaired by Corradino will be held to obtain input for this important project. It is through the public involvement process that the distribution of the conceptual design information is disseminated so that the consensus of the community and property owners in the public area of the work can be obtained.

The Corradino team will prepare a conceptual idea based on the best options available for accomplishing the required scope. We have identified the following tasks as key elements to address during scope refinement:

- Provide continuous coordination with the City, FDOT, General Consultant, and adjacent Project needs.
- Validate the project schedule to meet the phasing and deliverable needs in consultation with City staff.
- Survey the proposed route and location of the proposed sidewalk installation and repair producing both a Boundary and Topographical map.
- Coordinate permit efforts on issues that could impact the project, including possible coordination
  with existing SFWMD and NPDES permits, and other regulatory compliance issues.
- Identify construction phasing limitations and objectives.
- Initiate coordination with existing utility companies to avoid potential conflicts at the design level
- Initiate project access, phasing, and maintenance of traffic plans.
- Develop draft technical specifications and special provisions.
- Develop preliminary cost estimates.

After refined phasing alternatives have been developed with the City staff and initial feedback has been taken into account, a preliminary design report will be prepared containing the proposed design with associated cost and schedule impacts.

#### **MEETINGS AND PRESENTATIONS**

An initial meeting will be coordinated to kick off the project with City staff once the NTP is received. Based on feedback received during these initial meetings, alternatives will be explored to mitigate any concerns that are identified. Further refinement to these alternatives will be reviewed, and then presented to City staff on an iterative basis. These meetings will take into account the impact of the individual project phases on the project limits, the overall project schedule, and the project budget. Finally, a consensus-based preferred alternative will be published and detailed in a final Engineer's Report.

As a result of this phase, a concise plan for the design work required to provide for the installation of new sidewalks and for the correction and replacement of existing damaged sidewalks for those areas considered hazardous and unsafe. These areas include those unsafe conditions found in existing curbs, curb ramps, residential and commercial property driveway aprons and property entrances, bicycle and pedestrian crosswalks, signage and pavement markings, and traffic calming devices.

#### UTILITIES

The team will take the initiative to perform early coordination in order to minimize utility conflicts and to ensure utility work schedules are processed prior to the bid ability phase. Any required modifications to these existing utilities will be included in the construction documents.

#### MAINTENANCE OF TRAFFIC SAFETY (MOT) AND PHASING PLANS

It is always the intent of The Corradino team to consider safety factors when preparing construction documents and overseeing construction activities. Utmost attention will be given to the preparation of safety plans and construction phasing plans, thereby minimizing the impact to life and property during the course of this project. Detailed safety plans will be provided between the design team and the City to ensure safety during construction while minimizing disruption to traffic. Prepared safety plans will address contractor access, staging areas, control of personnel and equipment, and security measures that must be adhered to during construction.

The Contractor shall use the MOT plans provided in the bid documents as a basis for the final MOT coordination. Prior to any construction activities the Contractor will submit final MOT plans to the City staff for review and approval. At this time, the City staff may adjust the MOT layout to accommodate pedestrian and traffic flow. The Contractor will keep a copy of the approved-and-signed MOT plan on site at all times.

#### **CONSTRUCTION DOCUMENTS**

The Corradino team will prepare a coordinated set of plan documents and specifications predicated on the information outlined above. It is anticipated that these documents will be submitted and reviewed by City staff at the 60% and 100% milestones during the production phase of the project. In order to maintain schedule and meet the 60% complete design milestone for construction plans and specification documents for the Duck Avenue and 12<sup>th</sup> Street project by June 30, 2011, and final construction design and specification documents for the Duck Avenue and 12<sup>th</sup> Street project by August 20, 2011, the normal review points need to be truncated. Cost and schedule will be a key component of the review process.

Final design of the project will consist of the continuation of the preliminary design effort upon acceptance of the conceptual ideas of the preliminary design including:

- Complete construction phasing and maintenance of traffic plans.
- Provide bicycle path street pavement marking plan and details.
- Provide final design for sidewalks and any utility alterations
- Complete project access, general notes, and tables of quantities.
- Complete technical specifications and deviations to standards.
- Complete Special Provisions.
- Prepare final contract documents for bidding.
- Provide continuous updates of the project schedules and cost estimates throughout final design.

#### STATEMENT OF PROBABLE COST

During the design phase of the project, The Corradino team will initially prepare and maintain opinions of probable cost. These will be presented at each of the design review interim mile stones, with particular attention to material costs.

#### AGENCY APPROVALS

The Corradino team will be responsible for coordinating the final design documents with the various regulatory agencies. This will include early notification to the permitting agencies. We will work with the permitting and regulatory agencies during the course of design to assure that, at the completion of final

design, the plans and specifications meet local, state, and FDOT requirements. The Corradino team works with these regulatory agencies on a regular basis, and as such, is familiar with both the code requirements and the personnel involved in reviewing and approving the documents required to allow the work to be accomplished.

#### BID & AWARD

The Bid and Award phase of the project will consist of the formal advertisement and solicitation for bids from the contracting community and coordination with the City of Key West staff throughout the bidding process. Typical services provided by the Corradino team during the Bid and Award phase consist of the following elements:

- Printing of contract documents.
- Assist with advertisement as requested.
- Administer document distribution.
- Plans interpretation and clarification.
- Attend and conduct (if requested) the pre-bid meeting.
- Issue addenda as required and develop final reconciled cost estimates.
- Attend bid opening.
- Assist with technical review and ranking to attain qualified contractors.
- Provide bid tabulation and a recommendation of award.
- Provide complete conformed documents for the contract upon award.

#### SCHEDULE OF DESIGN ACTIVITIES

The Corradino Group team understands the importance of time in producing a conformed set of drawings and specifications in obtaining the best possible competitive construction pricing. When contractors have a clear and concise set of drawings and specifications, both the owner and contractor benefit on the final pricing.

Upon receipt of the Notification to Proceed (NTP), our team will immediately set up community meetings to identify areas of concern as well as areas of compatibility. We anticipate having a consensus-based preferred alternative Engineers Report completed within 30 calendar days.

In concert with completing the Engineers Report, Perez Engineering (PE&D) will be meeting with the various local utilities in order to minimize any potential conflicts and to engage them in the design process. By including them in the thought process of the project, we, as a global team, will ensure that the work effort will be focused on design completion, and not having to re-do work due to not clearly understanding the utility companies requirements. As PE&D is located in Key West and has worked with these various entities in the past, we expect this effort to be completed in the first 30 days as well.

Once the Engineers Report has been accepted, the primary design effort will begin in earnest. It should be understood that our team successfully completed sidewalk designs in Key West and other municipalities. As such, the details for sidewalks, including sidewalk repair, have been produced in these prior design packages. Modifications to these details may be required, but already having acceptable details from prior Key West sidewalks certainly accelerates the design effort as well as specification production. We will have a 60% design package ready for staff review by June 30, 2011. Since we our utilizing our Key West subconsultant Allen Perez as our Deputy Project Manager we expect to have staff interaction during the total design effort. We expect that only one formal review should be required at the 60% completion point. We will also expect to have a review at 100% completion; however, this review is to ensure that we have not omitted or overlooked any single item in the construction bid package. We are dedicated to the August 20, 2011 completion date, and all our team members will work the days

necessary to have a complete design and specification package completed and submitted to the appropriate Key West staff.

With a March 16, 2011 submittal date, we are anticipating a two to four-week review of the submittal packages, inclusive of short listing, and selection of the most qualified firm and approval by the City Commission. Once selected, we understand that we will have up to 30 days to negotiate a contract, inclusive of having and executed purchase order and a written Notice to Proceed letter. Based upon this timing we have anticipated a start date of May 15, 2011. Obviously, should the Corradino Group be selected for this work, we would expect a much shorter negotiation period as we have a clear understanding of the work at hand, a clear understanding of contractual requirements, and a strong desire to execute this project successfully. We also have executed work under the terms and conditions of the proposed contract and will be pleased to work under these same terms and conditions in the future.

#### **CONSTRUCTION PHASE SERVICES**

The diligence and attention given to the construction documents will provide an efficient construction phase of the project. This will establish procedures prior to the pre-construction meeting, enabling all involved parties to become acquainted with and understand responsibilities of each procedure. Additionally, team members will meet with the contractor to discuss and approve the contractor's quality control program and to establish the processes and procedures for construction administration. This process will provide an atmosphere of cooperation among the Owner, contractor, the CEI firm, and the project team. This approach has been successful on previous projects and has eliminated unnecessary paperwork, claims, and project delays.

The construction administration task will include weekly construction coordination meetings with the Owner, Contractor, and project team members. The Project Engineer will address requests for information, shop drawings, and other matters on site, thereby enabling the design team to provide prompt support. Every member of the design team has been involved with sidewalk construction projects and understands the importance of providing timely responses to any construction issues. The Corradino team will provide updates to the construction schedule during the weekly construction meetings if requested to do so.

This *Project Approach* has been prepared based on the Corradino team's extensive local knowledge of municipal construction projects, understanding and experience in working with the City of Key West, and the combined team's technical expertise. Key project Issues have been identified and initially addressed based on the information available.

## 2. RELEVANT PREVIOUS EXPERIENCE AND PROJECTS

Corradino has extensive experience with engineering projects and has an understanding of the design issues and requirements of these projects.
