

RESOLUTION NO. 24-042

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AWARDED THE BID OF CHARLEY TOPPINO & SONS, Inc. RECEIVED IN RESPONSE TO INVITATION TO BID (ITB) #24-008 FOR SOUTH STREET IMPROVEMENTS PROJECT IN A TOTAL AMOUNT NOT TO EXCEED \$3,513,261.06; AUTHORIZING ANY NECESSARY BUDGET ADJUSTMENTS AND AMENDMENTS; AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT IN SUBSTANTIAL CONFORMANCE WITH THE BID DOCUMENTS, UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the South Street Improvements project (Reynolds Street to Duval Street) is necessary to provide pavement rehabilitation and sidewalk upgrades following FCAA water main upgrades, along with stormwater, landscape, and bike lane improvements; and

WHEREAS, one bid was received in response to ITB 24-008, with Charley Toppino & sons, Inc. submitting the only responsive bid; and

WHEREAS, City staff find the lowest bid to be responsive and responsible, and recommends award of the bid to Charley Toppino & Sons, Inc.; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION
OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the bid of Charley Toppino & Sons,
Inc. is hereby awarded in response to ITB 24-008 for South
Street Improvements, in an amount not to exceed \$3,513,261.06

Section 2: That the project is funded in account
102-4102-541-6300 as project II41024002. Any additional
necessary budget adjustments or amendments are hereby
authorized.

Section 3: That the City Manager is hereby
authorized to execute a contract in substantial conformance
with the bid documents upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect
immediately upon its passage and adoption and authentication
by the signature of the Presiding Officer and the Clerk of
the Commission.
