**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING “INTEGRITY MULTISPORT, INC” & FLORIDA KEYS HEALTHY START COALITION.” TO CONDUCT A “KEY WEST TRIATHLON STARTING AT 7:00 AM AND ENDING AT 9:30 AM, DECEMBER 11, 2022 (SET-UP, DECEMBER 10, 2022, FROM 2:00 PM TO 8:00 P.M. AT HIGGS BEACH; AUTHORIZING CERTAIN STREET CLOSURES THEREOF DURING THE EVENT; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS** Integrity Multisport, Inc. and Florida Keys Healthy Start Coalition is hereby given permission to conduct a Triathlon on Sunday, December 11, 2022.

**NOW, THEREFORE, BE IT RESOLVED** by the City Commission of the City of Key West, Florida.

**SECTION 1.** That in Resolution 19-174, the City Commission directed the City Manager to “develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the provision of good or services, unless such use is otherwise preempted by law.”

**SECTION 2.** That the vendor/lessee/licensee acknowledges the City’s concern about the negative environmental impact of using disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/lessee/licensee/contractor therefore commits to refrain from the use of distribution of single-use polystyrene/plastic items, including but not limited to single-use polystyrene/plastic straws, bags, plastic utensils and “to go” packages for food or products sold on any property leased from the City.”

**SECTION 3.** That permission is hereby granted to conduct the Integrity Multisport, Inc. and Reef Relief, Inc on the date and during the hours stated above; **PROVIDED** that all trash is

adequately collected and contained; that a guarantee indemnifying the city is executed; that the organization meet the terms and conditions set forth by the City Manager.

**SECTION 4.** That Integrity Multisport, Inc and Florida Keys Healthy Start Coalition is hereby granted permission for the closure of certain streets throughout the city for the Key West Triathlon on the date and during the hours stated above.

**SECTION 5** That the race will consist of a Swim 400, bike 10 miles, run 3.1 miles. Racers will start with a swim in the ocean off Higgs Beach, then get on their bikes and continue with the bike portion, followed by the 3.5 miles, which will be on the sidewalk.

**SECTION 6.** That Integrity Multisport, Inc. and Florida Keys Healthy Start Coalition will be coordinating with the Key West Police Department for their part in the race.

**SECTION 7.** That the Event organizers will adhere to the recycling plan of the city of Key West, that one (1) recycling container for everyone (1) trash barrels will be used and that they will be placed side by side.

**SECTION 8.** That the event organizer shall use removable chalk or another readily removable substance for all course markings placed on public property.

**SECTION 9.** That the applicant acknowledges this authorization may be revoked by the Commission or the City Manager, due to exigent circumstances such as the resurgence of COVID-19 in the community.

**SECTION 10.** That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
