A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA APPROVING A TASK ORDER FROM CHARLEY TOPPINO AND SONS, INC. TO REHABILITATE EIGHT (8) STORMWATER WELLS IN THE AMOUNT OF \$224,400.00 (\$28,050.00 EACH) UNDER THE GENERAL UTILITIES CONTRACT APPROVED BY RESOLUTION NO. 25-103; AUTHORIZING THE CITY MANAGER TO EXECUTE ALL NECESSARY DOCUMENTS AND BUDGET TRANSFERS OR ADJUSTMENTS, UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City owns and operates 92 stormwater injection wells as part of the City's stormwater collection system. Over time sediment and debris deposits diminish well capacity which, in turn, reduces the system design efficiency; and

WHEREAS, to ensure our collection system operates as designed, these wells require periodic cleaning or "rehabilitation" and those wells identified by Utilities as "underperforming" are rehabilitated as budget allows, as part of an ongoing maintenance effort; and

WHEREAS, authorizing this Task Order will approve the following eight (8) wells for rehabilitation; and

- 100 Grinnell ST. & Trumbo Rd. (Ferry Terminal) (Gravity)
- Angela and Margaret (Gravity)
- Southard and Margaret (Gravity)
- Catherine and Varela (Gravity)
- William St. & Louisa St. (Gravity)
- Laird and Thompson (Gravity)

- Southard St and White St (Gravity)
- Eaton St and White St (Gravity)
- ALTERNATE; Amelia St and Whitehead St (Gravity)

WHEREAS, funds for Stormwater Well Rehabilitation have been, and will be, annually budgeted in Stormwater Construction/Repair and Maintenance Account #4023803-5384600; and

WHEREAS, staff recommends the City Commission approve the Task Order from Charley Toppino and Sons, Inc. in the total amount of \$224,400.00 (\$28,050.00 each) for rehabilitation of the eight(8) above-listed stormwater wells;

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1.
