Good afternoon Mayor and Commissioners,

I am writing to express my firm disapproval of the attempt to fire our current City Manager, Al Childress. After just over a year of investment, and at a critical time, this would be a disaster for our community.

Upon hearing about this meeting, I reviewed the Performance Evaluation from the April meeting, as well as all of the individual evaluations and comments. I see nothing in those notes and evaluations that should result in his firing. I am aware that Mr. Childress has worked to implement policies and procedures, which I believe are crucial to a well-functioning work environment. I am also aware that he has ruffled some feathers with some of his policies and procedures. These items were mentioned in the evaluations, and all but one Commissioner graded with an average less than 3 (Carey), and noted a need for significant improvement. Giving someone a 3 or higher on their evaluation, and then calling for their firing, is quite curious. (I've attached the summary of scores to this email for ease of reference.) What has changed in the 2 months since these were written? Did these Commissioners not take the evaluation seriously and provide proper feedback? I do see several references in the evaluations to his relationship with the City Attorney, who we are all well aware is pulling extremely long hours. Is there more to this that citizens should be made aware of? I would be more concerned if Mr. Childress had not ruffled any feathers in his first year! Perhaps those with ruffled feathers are the ones who need to be more flexible rather than pushing out Mr. Childress.

Unless I have overlooked it, it seems that Mr. Childress has not been provided with clear directives and goals for his employment. Nobody should be removed from their position when they have not been

provided these goals, and the opportunity to meet them. If Commissioners do not respect and value the evaluation process, then you cannot expect the person being evaluated to make improvements...it is part of the process, and these procedures are necessary and valuable.

I read the memorandum Mr. Childress provided the Commission, and it is clear he has faced a lot, and accomplished a lot, in just one year. He seems to have balanced quite well getting out in the community with his work inside City Hall. You all know as well as I do that learning and being considered part of this community takes more than a year. I cannot imagine being expected to make more impact without clear directives that are created in unison by the City Commission and Mayor. I am aware that Mr. Childress has promoted from within, which I believe shows his commitment to the city and the current staff. I know that he has secured grants and located overlooked funds. Fresh eyes are a great thing! I am also certain that he has far too many open positions to fill (through no fault of his own), and firing him now will not help fill those positions. This push for immediate action, after barely a year in office, seems short-sighted and inconsiderate of our needs as a city. Mr. Childress has invested in this community, and the majority of citizens have expressed grave concerns with this potential removal from his position. You were all elected to represent your constituents and I would hope you will set aside any personal conflicts, and vote accordingly, giving this man a chance to continue to make improvements. **Dear Mayor and City Commissioners:** 

My name is Brandon Jones and I reside at 411 Louisa Street, in Key West's district 6. I am writing to you all today regarding the special meeting scheduled for 2:00pm on June 26, 2023, and the topic of ending the employment relationship between the city and Albert Childress without cause.

I am opposed to this action, and I am asking you to oppose the resolution. I offer the following reasons for consideration:

- 1. Mr. Childress has been in the position for a little over a year and by all public accounts, including reports of overwhelmingly positive (non-negative) remarks on Mr. Childress' recent performance review it seems he is at least meeting reasonable expectations for a first-year city manager. Based on available information since those performance reviews, it is not clear what has changed. It is unwarranted to jump directly to termination without cause at this time.
- 2. The cost to terminate Mr. Childress without cause is significant. The 20 weeks' salary Mr. Childress would be entitled to is considerable enough on its own; however, associated costs include: additional legal bills from an outside attorney that advises and travels from Orlando, legal expenses related to potential litigation from Mr. Childress if he challenges the lawfulness of the decision, recruitment costs for a new city manager, and the unquantifiable costs of delayed projects and loss of productivity while the role is in transition. For the residents to assume these costs, it is reasonable to expect that the justification is stronger than "without cause."
- 3. Recruitment will be a challenge for this role, and future city leadership roles. I imagine any qualified candidate will be aware their predecessor was terminated after one year of employment without cause. Despite the allure of living in our beautiful city, many qualified candidates may

self-withdraw or abstain from consideration out of concern for stability, especially considering they will be inheriting a role that has had significant turnover in the last several years. I cannot emphasize this enough. Would you want to risk uprooting your life if you were subject to termination without cause at such an easy whim?

Of course, there is a reason that some of you may support the decision to terminate Mr. Childress that extends beyond what is defined as "without cause" in the employment agreement. But for immediate dismissal, one imagines zero-tolerance offenses such as abuse, harassment, theft, unlawful conduct or other serious matters – all things that would raise to beyond the level of "without cause" if they in fact existed. If your intentions are to support the decision to terminate Mr. Childress "without cause," I ask you to consider if your reason to support termination justifies the three points I bring to your attention in this letter – especially if you were going to be one of the three new commissioners inheriting this transition. Please oppose the proposed resolution to terminate Mr. Childress without cause.

This extreme measure is sponsored by Commissioners Lisette Carey and Billy Wardlow. The resolution proposes that Mr. Childress be fired without cause. It does not propose anyone to replace Mr. Childress on an interim basis, nor does it provide a succession plan to retain a new manager.

Mr. Childress has been a highly effective manager who has consistently operated with integrity and transparency. He has made our City more accountable to its residents and refused to grant special favors to special interests. In doing so, he has made some powerful enemies.

Based on the facts, we support Mr. Childress without reservation. We urge you to attend the special meeting this Wednesday and ask Commissioners to vote no on this unwise resolution.

Even if there were cause to sanction Mr. Childress (and our inquiries have found none) terminating him at this time with no succession plan would be a highly irresponsible act that would rob the people of Key West of the good government we deserve, put public safety at risk, and waste taxpayer money. Consider:

- 4 of the 7 current Commissioners are term-limited and will be out of office after the August 20 election, when 4 new Commissioners will be sworn in. Terminating the manager now is like burning down the house before handing over the keys.
- Hurricane season is underway. When Key West is impacted by summer storms, the City
   Manager coordinates an all-hands-on-deck effort involving Police, Fire, and all City

departments to protect public safety and property interests. The health and safety of our residents demands steady leadership during this volatile time of year.

 Terminating the manager without cause will cost taxpayers at least \$100,000 in severance payments. Additionally, the City has already committed unknown costs to outside counsel for Wednesday's meeting, owing to the City Attorney's conflict of interest.
 There may also be future legal fees and damages for wrongful termination.

The above facts are overwhelmingly in favor of keeping Mr. Childress as manager. Those pushing for his ouster have provided no facts whatsoever to merit his termination.

Please write or call the Commission today to support the City Manager and urge them to vote no on his proposed termination. Copy City Clerk Keri O'Brien and ask that your email be attached to the agenda as public comment.

It has been a rough couple of weeks at Key West City Hall.

The culmination has been the surprising recent revelation that our elected leaders believe the City needs to replace Key West City Manager, Albert Childress, after 14 months of a 4-year contract.

For those not following City Hall, Mr. Childress was hired and began work in April 2023. Mr. Childress was selected via a professional search on the recommendations of a City Commission appointed Selection Committee comprising respected and experienced City Leaders. By all indications, bringing in Childress appeared to be an exceptional find based on qualifications, 35 years, professional experience with 25 years in senior governmental executive roles in South Florida and education including multiple graduate degrees in business and public administration.

Ironically, Mr. Childress was recently evaluated where a super majority of our elected leaders gave him glowing accolades. His accomplishments included strong support for public safety (police and fire), emphasis on a cleaner City, a focus on communications and informing the public and setting standards for staff accountability for responsiveness to residents. He has streamlined monthly City Commission meetings, hired an experienced Human Resources Director, completed successful labor negotiations, while fully engaging with the community. His community engagement has included invitations to groups to present at City Commission meetings and attendance and speaking engagements at numerous community meetings.

Suddenly, with some very tough situations and decisions, a narrative has evolved with criticisms such as: too regimented and authoritarian, a big City mentality, moving too fast, morale issues, and losing our best/brightest. To date, there has been a lack of substantive evidence to support his removal. To almost anyone on the outside, the appearance of this proposed action is an ill-timed knee jerk reaction as we enter the thick of Hurricane Season and approve the City's fiscal 2025 annual budget.

Our excellent local media sources including social media appear to point to a strong community sentiment in support of City Manager Childress despite a small vocal minority. For example, our own Keys Citizen have labeled the removal with a Jeer and our community pulse, the Citizens Voice, has come out in support of Mr. Childress 15-1 to date and counting. As far as one can tell, Mr. Childress's propensity to embrace change, particularly bringing sunshine to local government, allowing a resident vote on financing options, and his perseverance to tackle legacy internal problems related to control over future development, among other items has brought us to this day of reckoning.

And all this is happening in lightning speed in the dead of summer with a hastily called Special City Commission Meeting on the eve of the largest turnover of elected policy makers in recent City History.

As of this writing, the future is uncertain. All we can ask for come Wednesday is a venue welcoming open minds and public input, a thoughtful and thorough discussion and evaluation of the facts and circumstances, and a respectful dialogue and decision. I am hoping that this process will place the best interests of All Residents first. For in the end, I believe we can be united by the love we all share for Key West. I choose to believe these are the times when we are at our best.

Good afternoon Mayor and Commissioners,

I am writing to express my firm disapproval of the attempt to fire our current City Manager, Al Childress. After just over a year of investment, and at a critical time, this would be a disaster for our community.

Upon hearing about this meeting, I reviewed the Performance Evaluation from the April meeting, as well as all of the individual evaluations and comments. I see nothing in those notes and evaluations that should result in his firing. I am aware that Mr. Childress has worked to implement policies and procedures, which I believe are crucial to a well-functioning work environment. I am also aware that he has ruffled some feathers with some of his policies and procedures. These items were mentioned in the evaluations, and all but one Commissioner graded with an average less than 3 (Carey), and noted a need for significant improvement. Giving someone a 3 or higher on their evaluation, and then calling for their firing, is quite curious. (I've attached the summary of scores to this email for ease of reference.) What has changed in the 2 months since these were written? Did these Commissioners not take the evaluation seriously and provide proper feedback? I do see several references in the evaluations to his relationship with the City Attorney, who we are all well aware is pulling extremely long hours. Is there more to this that citizens should be made aware of? I would be more concerned if Mr. Childress had not ruffled any feathers in his first year! Perhaps those with ruffled feathers are the ones who need to be more flexible rather than pushing out Mr. Childress.

Unless I have overlooked it, it seems that Mr. Childress has not been provided with clear directives and goals for his employment. Nobody should be removed from their position when they have not been provided these goals, and the opportunity to meet them. If Commissioners do not respect and value the evaluation process, then you cannot expect the person being evaluated to make improvements...it is part of the process, and these procedures are necessary and valuable.

I read the memorandum Mr. Childress provided the Commission, and it is clear he has faced a lot, and accomplished a lot, in just one year. He seems to have balanced quite well getting out in the community with his work inside City Hall. You all know as well as I do that learning and being considered part of this community takes more than a year. I cannot imagine being expected to make more impact without clear directives that are created in unison by the City Commission and Mayor. I am aware that Mr. Childress has promoted from within, which I believe shows his commitment to the city and the current staff. I know that he has secured grants and located overlooked funds. Fresh eyes are a great thing! I am also certain that he has far too many open positions to fill (through no fault of his own), and firing him now will not help fill those positions. Over the years, I have sent many emails to all levels of employees and elected officials in the City, and I have been impressed with the fact that Mr. Childress has responded both timely and thoroughly.

I have been here for over 21 years now, and we have been through quite a list of City Managers. Yes, we are a unique place, with unique requirements, but we also need to be flexible, and provide proper time and support for a new City Manager. Ousting Mr. Childress as we go into storm season, with no Assistant City Manager, and more than one major department head position vacant, would be a disaster, and, in my opinion, completely unnecessary. I have seen no evidence to the contrary, but please feel free to share.

We have a new Mayor and several new Commissioners coming in who will need to learn to work with the City Manager, and he with them...why not allow this to happen? This push for immediate action, after barely a year in office, seems short-sighted and inconsiderate of our needs as a city. Mr. Childress has invested in this community, and the majority of citizens have expressed grave concerns with this potential removal from his position. You were all elected to represent your constituents and I would hope you will set aside any personal conflicts, and vote accordingly, giving this man a chance to continue to make improvements. There will always be need for improvement, but making this position a revolving door, or putting someone in it simply because they're "from here", is not supportive of the citizens, or the city itself. I also find it curious that the potential appointee for this position, should a vote to remove occur, is not yet made public. Is there a reason for this? Transparency in this process seems crucial and this is a critical piece that should be considered.

Unfortunately, I will be in meetings all day on Wednesday and unable to attend this special meeting (called in the middle of the work day?). I would appreciate responses to my questions.
