#### Narrative

NARRATIVE OF INCIDENT

See Ofc. Gruba's Attached Report:

On 04/18/2025, at approximately 1750 hours, I, Ofc. Gruba, was dispatched to 1500 Reynolds St, Casa Marina, in reference to a male yelling at everyone and trying to fight security.

Upon arrival, several hotel guests told me the man I was there for had been causing a scene for a while. I was escorted to the courtyard of the hotel by one of the managers. I immediately saw the male, later identified as Kenneth Hamlin, by the pool area, yelling obscenities at no one in particular and walking away from security as they were telling Hamlin to leave. All the hotel guests in the courtyard and pool area were watching Hamlin as he yelled obscenities. It was immediately apparent by Hamlin's posture, overly sweaty body, slurred rapid speech and distant stare, that he was under the influence of alcoholic intoxicants and narcotic intoxicants as well. I identified myself as a law enforcement officer to Hamlin and asked him to walk off the property with me. Hamlin, seeming to look straight through me, not acknowledging me, continued to yell. I told Hamlin to place his hands behind his back. Hamlin immediately tensed up as Ofc. Roman and I attempted to get control of his arms.

After a brief struggle, I performed a single leg takedown on Hamlin, grabbing Hamlin's right leg, lifting, and escorting Hamling to the ground. Once on the ground, Hamlin continued to resist by pulling his arms away myself and Ofc. Golovanov, who was trying to gain control of his left arm. Ofc. Golovanov and I eventually got Hamlin's arms behind his back and in handcuffs. Hamlin was escorted off the property and into the back of my patrol vehicle. Hamlin refused to give me his name and date of birth. Sgt. Stutz was eventually able to get Hamlin's information.

I was shown a video of Hamlin pushing a security guard, identified as Ronald Mahoney. Mahoney stated that he did wish to pursue charges for battery. Also on behalf Casa Marina, Mahoney wished to pursue charges for trespassing and disorderly conduct. Ofc. Bernatova gave Mahoney a victim's rights brochure with my name and case number on it.

Prior to Mahoney being asked to leave by security, Mahoney had rung up a \$494.21 bill at the bar. It is suspected Mahoney fraudulently rang up a tab, billing it to a room that did not belong to him. Ofc. Bernatova is investigating this further.

I transported Hamlin to Monroe County Detention Center. Due to Hamlin's erratic and aggressive behavior, he was immediately placed in the restraint chair and in a spit hood by Detention Deputies.

Kenneth Hamlin violated Florida State Statute 784.03-2, Battery-2nd offense. Hamlin actually and intentionally touched or struck Mahoney against his will. A criminal history check reviled Hamlin pled guilty on 07/21/2021 for battery (domestic violence) in Las Vegas.

Kenneth Hamlin violated Florida State Statute 810.09-2B, Trespassing, fail to leave upon order from owner. Hamlin willfully remained on Casa Marina property after being asked to leave multiple times by Casa Marina security (Mahoney).

Kenneth Hamlin violated Florida State Statute 877.03, Disorderly conduct. Hamlin committed an act or acts that were of a nature that corrupted the public morals and outraged the sense of decency at Casa Marina. Hamlin's acts affected the peace and quiet of guests at the hotel. This was evident in the video I saw of Hamlin pushing Mahoney. In the video multiple people had their phones out, recording the incident. When Hamlin pushed Mahoney people can be heard gasping in shock. Also, upon my arrival, hotel guests were still gathered in the courtyard area, cautiously observing Hamlin's bizarre behavior.

Kenneth Hamlin violated Florida State Statute 843.02, Resist officer without violence. Hamlin resisted, obstructed, opposed my lawful commands to leave the property of Casa Marina, followed by tensing up when asked to put his hands behind his back, followed by refusing to identify himself to me. At the time I was an officer at Key West Police Department and engaged in the lawful execution of a legal duty. At the time Hamlin knew I was an officer due to my class "B" uniform and patrol vehicle.

My BWC was activated. Video of the battery will be uploaded to evidence.com

Upon arrival, I observed Ofc. Gruba and Ofc. Roman were standing with the subject in the pool area. The subject (Kenneth D. Hamlin, DOB: 06/01/1980) remained belligerent and refused to place his hands behind his back. I grabbed Hamlin's left arm in an attempt to place it behind his back. Hamlin immediately tensed his left arm.

Ofc. Gruba executed a controlled takedown, bringing Hamlin to the ground. At this moment, my body-worn camera (BWC) became detached from my chest and fell to the ground. While Hamlin was lying on his stomach, he continued to resist my attempts to place his left hand behind his back by tucking it under his chest. However, Ofc. Gruba and I were eventually able to successfully handcuff Hamlin (see Ofc. Gruba report for greater details).

On April 18, 2025, at approximately 1755 hours, I, Officer V. Roman responded to 1500 Reynolds Street (Casa Marina Resort) in reference to a physical altercation.

On arrival, I was directed to the pool area of the resort by hotel staff. As I arrived in the courtyard area behind the resort, I observed a Hispanic male who was later identified as Kenneth Daniel Hamlin (Arrestee) yelling and behaving in a belligerent manner. Kenneth was asked by Officer Gruba to keep walking while being pointed in the direction of the hotel lobby area. Kenneth continued singing using derogatory words, causing a scene with hotel guest and staff present.

As Ofc. Gruba and I grabbed onto Kenneths arms, Kenneth tensed up by locking his arms in place while saying "Bitch you ain't stronger than me."

Based on Kenneths demeanor and Kenneth actively resisting Officers, Kenneth was redirected to the ground.

While on the ground in a prone position, Kenneth continued to resist by locking his arms under and along him upper body. I grabbed on to Kenneths legs, placing them into a four-figure leg lock to prevent him from kicking or attempting to stand up.

Kenneth was placed into handcuffs by Ofc. Gruba and escorted to Ofc. Gruba's marked patrol vehicle.

At the time of this incident, I was on duty and in my full Key West Police Department uniform, clearly identifiable as a Police Officer; based on the silver badge emblem that reads "Officer Key West Police FLA." above my left breast, "Key West Police" patches on each shoulder, and a silver pin on the right and left side of my collared shirt, that read "KWPD." All of this took place in Key West, Florida.

My BWC was activated during this investigation.
