A RESOLUTION OF THE CAROLINE STREET CORRIDOR AND BAHAMA VILLAGE COMMUNITY REDEVELOPMENT AGENCY (CRA) AWARDING THE BID TO SHARP EDGE CONSTRUCTION, INC., IN RESPONSE TO ITB NO. 25-021, IN A TOTAL AMOUNT NOT TO EXCEED SIXTY-SIX THOUSAND EIGHT HUNDRED DOLLARS (\$66,800.00), FOR THE FREDERICK DOUGLASS GYM SPALLING AND WINDOW REPAIR PROJECT (BV55022501-5556200); AUTHORIZING THE CITY MANAGER TO EXECUTE ALL NECESSARY DOCUMENTS, BUDGET TRANSFERS AND AMENDMENTS IN CONFORMANCE WITH THE BID DOCUMENTS, UPON CONSENT OF THE CITY ATTORNEY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City issued Invitation to Bid (ITB) No. 25-021, *Building Structural Repairs - Frederick Douglass Gym*; and

WHEREAS, four (4) bids were received and opened on December 3, 2025; and

WHEREAS, after review, staff recommends award of the bid to the lowest responsive and responsible bidder, Sharp Edge Construction, Inc.; and

NOW, THEREFORE, BE IT RESOLVED BY THE CAROLINE STREET CORRIDOR AND BAHAMA VILLAGE COMMUNITY REDEVELOPMENT AGENCY, AS FOLLOWS:

Section 1: That the bid of Sharp Edge Construction,

Inc. is hereby awarded in the amount of Sixty-Six Thousand Eight Hundred Dollars (\$66,800.00) in response to ITB No. 25-021, *Building Structural Repairs - Frederick Douglass Gym*, the terms and conditions of which are incorporated herein by reference. Funding for this project is budgeted in the Building Fund, Account No. 6015502-5556200 (Project No. BV55022501-5556200).

Section 2: That the City Manager is authorized to execute any necessary documents, budget transfers and amendments, in conformance with the bid documents, upon the advice and consent of the City Attorney.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Agency.
