A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING PURSUANT TO CODE OF ORDINANCES 2-797(4)(b), BEST INTERESTS OF THE CITY AND 2-844 BRAND NAME SPECIFICATIONS, THE PURCHASE OF FOUR (4) 2017 HARLEY DAVIDSON POLICE ROAD KING MOTORCYCLES FROM ALLIGATOR ALLEY HARLEY DAVIDSON FOR USE BY THE KEY WEST POLICE DEPARTMENT IN AN AMOUNT NOT TO EXCEED \$77,398.20; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Police Department finds that Harley Davidson Road King Police motorcycles best meet department needs based on performance, rider training, maintenance and service history and, in conjunction with the purchasing agent, has determined that a name brand specification is necessary, pursuant to Section 2-844 of the Code of Ordinances; and

WHEREAS, City staff obtained price quotes from the two vendors within reasonable distance from Key West for factory authorized service and maintenance, and determined that the quote provided by Alligator Alley Harley Davidson of Sunrise was the lowest price; and

WHEREAS, the City Manager has determined that the purchase of Harley Davidson Road King Police Motorcycles from Alligator Alley, is in the best interests of the City pursuant to section 2-797(4)(b) of the Code of Ordinances; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached purchase agreement for four (4) 2017 Harley Davidson Road King Police Motorcycles, from Alligator Alley Harley Davidson of Sunrise, in an amount not to exceed \$77,398.20 is hereby approved, pursuant to Section 2-797(4)(b), best interests of the City, and Section 2-844, brand name specifications, of the Code of Ordinances.

Section 2: That funding for this purchase is budgeted in account #101-2101-521-6400 for police department machinery and equipment for FY 16-17.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
