### -- Dylan J Demarco Arrest Narrative:

On March 14, 2023, at approximately 2330 hours, I, Ofc. Lopez was on foot patrol near the intersection of Duval Street and Charles Street. While I was standing at the above-mentioned intersection, I noticed a security staff member escorting one male out of Irish Kevin's, (211 Duval Street). The security staff member was back inside the establishment while the male stood in front of the entrance. The male was standing in front of the main entrance and facing towards the entrance. The male continued standing on the sidewalk and he appeared as if he was looking for a reaction from the staff members. The male was later identified with his New Jersey driver's license as Dylan DeMarco, (dob:09/06/2002).

I crossed the street towards the entrance of Irish Kevin's to intervene and prevent Dylan from fighting the security staff members. I recognized Dylan from earlier this afternoon while I was working an off-duty detail at Dante's Pool Bar, (955 Caroline Street). When I was at Dante's I was informed by the security staff members that Dylan attempted to use someone's identification and he was not allowed to get in. Dylan left the property and then he returned to the property thinking he was going to be allowed to get in with his parents. However, he was not allowed to get in, and he left shortly after.

I walked up to Dylan, and I told him to stop. As I was grabbing Dylan's left arm and instructing him to come with me, Dylan pulled his arm away from me and he said, "I'm done" several times. I used my left hand to grab Dylan's wrist and once I placed his left arm behind him, he turned his body towards his right side, and he continued saying, "I'm done". Once Dylan turned his body towards me, he managed using his right hand to push me on my chest area and knocking down my body worn camera from my vest. As Dylan was pushing me, he said "Fuck" and he appeared to be upset. Dylan tried to get away from me after pushing me on my chest. As Dylan was trying to get away from me, I had to escort him to the ground in an attempt to place handcuffs on him.

Once Dylan was laying on the ground, (Facing down), Ofc. Roberts assisted me. While I was attempting to place handcuffs on Dylan, he began tensing up and he tried to pull his arms away. I was able to place handcuffs on him and Ofc. Roberts walked him towards his patrol vehicle. I began searching Dylan and then he started hitting his forehead against the hood of the patrol vehicle.

Ofc. Robert assisted Dylan with sitting down on the ground to prevent Dylan from hitting his forehead. Sgt. Revoredo spoke with Dylan about his injuries and then Ofc. Roberts placed Dylan inside Thornbrugh's patrol vehicle.

Ofc. Thornbrugh later transported Dylan to the Monroe County Detention Center. The nurse at the MCDC requested to have Dylan to get medically cleared at the Hospital first. Ofc. Thornbrugh later transported Dylan to the Lower Medical Center to get medically cleared. Dylan was medically cleared, and he was transported back to The Monroe County Detention Center.

Based on the facts and evidence, Dylan Demarco, did knowingly and willfully used his hand to push me on my chest. As Dylan was pushing me with his hand, he managed knocking down my body worn camera from my vest, (This was captured with my body worn camera, 3722). I was wearing my class B uniform with the Key West Police insignia on m sleeves. I was recognizable as a Police Officer. I was performing my legal duties as a Police Officer, I had to intervene, and make contact with Dylan to deescalate the situation and prevent him from fighting the security staff members at Irish Kevin's Bar. Contrary to F.S.S. 784.07

Based on the facts and evidence, Dylan Demarco, did knowingly and willfully used his hand to push me on my chest. As I was grabbing Dylan's left arm and instructing him to come with me, Dylan pulled his arm away from me and he said, "I'm done" several times. I used my left hand to grab Dylan's wrist and once I placed his left arm behind him, he turned his body towards his right side, and he continued saying, "I'm done". Once Dylan turned his body towards me, he managed using his right hand to push me on my chest area and knocking down my body worn camera from my vest. Dylan refused to follow my verbal commands and intentionally pushed on my chest. Dylan tried to get away from me after pushing me on my chest. Dylan failed to get away from me, and I had to escort him to the ground in an attempt to place handcuffs on him. I was wearing my class B uniform and the Key West Police insignia on m sleeves. I was recognizable as a Police Officer, and I was performing my legal duties as an Officer. Contrary to F.S.S. 843.01.

Based on the facts and evidence, Dylan Demarco, did knowingly and willfully tried to engage in a fight on Duval Street with the security staff members at Irish Kevin's Bar. Dylan tried to engage the security staff members at Irish Kevin's Bar after he was escorted out of the establishment. Dylan was standing in front of the main entrance of the establishment, (Facing the entrance) as if he was looking for a reaction from the security staff members. Dylan was still standing in front of the establishment to the point I had to cross the street and intervene to prevent Dylan from fighting. During my interaction with Dylan and the attempt I made to maintain the peace, Dylan refused to follow my verbal commands. During my interaction with Dylan, he intentionally and aggressively pushed me on my chest. During my interaction with Dylan, I smelled a strong odor of an alcoholic beverage emanating from his breath. Contrary to F.S.S. 877.03.

On Tuesday 03/14/2023 at approximately 2232 hrs. while on foot patrol on the 200 block of Duval St. I (Ofc. E. Roberts) observed Dylan Demarco being escorted from Irish Kevin's Bar (211 Duval St).

Bar security escorted Demarco to the sidewalk in front of the establishment. Demarco persistently attempted to gain reentry into the establishment by physically forcing his way past security staff to no avail. Ofc. J. Mayorga-Lopez approached Demarco attempting to escort him away from the establishment. Demarco continued his persistent attempts to return and Ofc. Lopez took a custodial hold of Demarco. When Ofc. Lopez began escorting Demarco across Duval St. Demarco attempted to break Ofc. Lopez's custodial hold and flee. Ofc. Lopez and I regained control of Demarco and redirected him to the curb in front of 208 Duval St. (Red Garter Saloon). Demarco was placed in handcuff restraints and escorted to a patrol car that was parked on Charles St. While Ofc. Lopez searched Demarco's person he began to slam his head, face first, onto the hood of the patrol car. We then moved Demarco to a seated position on the ground where he attempted to further harm himself by thrashing his head towards the ground.

Demarco was secured in Ofc. E. Thornbrugh's patrol car and transported to the Monroe County Detention Center.

My Axon BWC was activated during this incident and uploaded to Evidence.com.
