A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE ATTACHED "SECOND AMENDMENT TO MEMORANDUM OF AGREEMENT FOR PARTICIPATING FORT LAUDERDALE UASI (URBAN AREA SECURITY INITIATIVE) AGENCIES" PURSUANT TO A FEDERALLY FUNDED SUBGRANT AGREEMENT BETWEEN THE STATE OF FLORIDA DEPARTMENT OF EMERGENCY MANAGEMENT AND THE CITY OF MIRAMAR, AS ADMINISTRATOR FOR THE DEPARTMENT OF HOMELAND SECURITY UASI GRANT PROGRAM FOR THE FORT LAUDERDALE URBAN AREA, IN THE AMOUNT OF \$42,000.00, TO FUND EMERGENCY RESPONSE REGIONAL PLANNING, RECRUITMENT, TRAINING, EXERCISING, PROVISION OF SUPPLIES AND EQUIPMENT AND/OR CONTINUATION OF EDUCATION FOR THE SOUTH FLORIDA CITIZEN CORPS TASKFORCE; AUTHORIZING THE CITY MANAGER TO EXECUTE THE NECESSARY DOCUMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the State of Florida, Division of Emergency Management has allocated funds from the Department of Homeland Security for the Ft. Lauderdale area (including Key West), through the FY 2009 UASI Grant Program; and

WHEREAS, the City of Key West, as a participating agency, has been awarded funding to recruit, train, purchase equipment and continuing education for the South Florida Citizen Corps Taskforce, in the amount of \$42,000.00 under a subgrant agreement with the Florida Division of Emergency Management, administered by the City of Miramar; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached "Second Amendment to Memorandum of Agreement for Participating Fort Lauderdale UASI Agencies," in the amount of \$42,000.00, is hereby approved.

Section 2: That the City Manager is authorized to execute the necessary documents to enact this Agreement, upon advice and consent of the City Attorney.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
