An application was received requesting the removal of **(2) Gumbo Limbo trees**. A site inspection was done and documented the following:

Tree Species: Gumbo Limbo (Bursera simaruba)

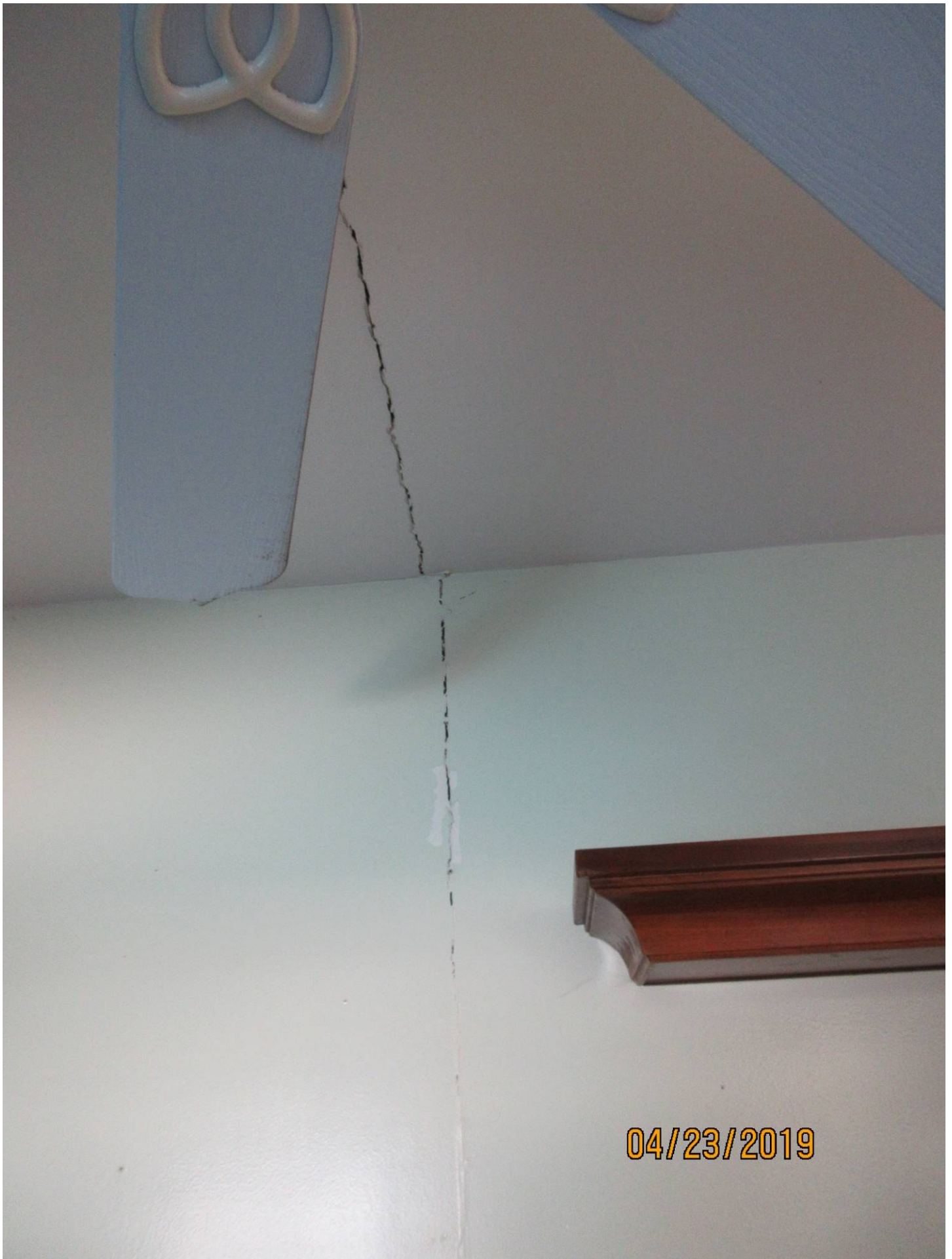

Diameter: 18.1"

Location: 30% (growing too close to structure, cracks to interior walls and ceiling, growing on property line-majority of tree trunk on this property)

Species: 100% (on protected tree list)

Condition: 50% (fair to poor, poor structure, numerous large canopy branches off one crotch area as if tree top had been cut at one time, fair health)

Total Average Value = 60%

Value x Diameter = 10.8 replacement caliper inches















Diameter: 6.6"

Location: 30% (volunteer tree growing under utility lines, on property line, in fence, and next to pool equipment.)

Species: 100% (on protected tree list)

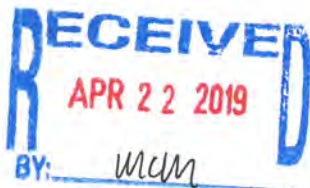
Condition: 50% (fair to poor)

Total Average Value = 60%

Value x Diameter = 3.9 replacement caliper inches

Total required replacement if both trees removed is 14.7 caliper inches.

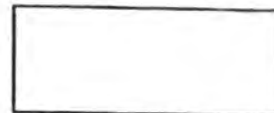

Tree #1 is pushing on the roof of the pool house. The fencing is already damaged and the roots of the tree has caused cracking to the pool house interior walls, floor and ceiling.

Tree #2 has already moved the fence to the extent of damaging the electrical service to the pool pump and will cause imminent damage to the hard piping of the pool filtration system.
