A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE PROCUREMENT OF 600 STACKING CHAIRS AND 20 CARTS FOR THE COFFEE BUTLER KEY WEST AMPHITHEATER AT A COST OF UP TO \$65,505.46, FROM MITYLITE, INC. THROUGH PIGGYBACKING ON THE BUYBOARD COOPERATIVE NO. 667-22 CONTRACT, PURSUANT TO SECTION 2-797(3) OF THE CODE OF ORDINANCES; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS OR ADJUSTMENTS; AUTHORIZING THE CITY MANAGER TO EXECUTE DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, this procurement will be made pursuant to government contract - BuyBoard Cooperative No. 667-22, pursuant to section 2-797(3) of the Code of Ordinances.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the procurement of stacking chairs at a cost of up to 65,505.46, from MityLite, Inc., as described in the attached quote acknowledgement Number SQ59722, dated 2/1/2025, pursuant to Section 2-797(3) of the Code of Ordinances, is hereby authorized.

Section 2: That adequate funds for this procurement are budgeted in Truman Waterfront/Amphitheater/Operating Supplies account #105-7507-575-5300. Any necessary budget transfers or adjustments are hereby approved.

Section 3: That the City Manager is authorized to execute documents in substantial conformity with the BuyBoard MityLite contract 667-22 and Quote Acknowledgement SQ59722, upon the advice and consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
