Investigation (continued)

Investigation Details

On 11.24.25 at about 0550 hours, I, Sgt. C Sims, responded to the area of Elizabeth St and Lazy Way Lane. This was in reference to an RRI that had just occurred.

Prior to this I had heard a call for service be dispatched for a suspicious white male in the area of Greene St and Duval St. This male was reported to be wearing a red t-shirt and gray shorts. Also, the caller said the male was actively trying to break into closed businesses in the 200-BLK Duval St. and had a large rock in his possession. Officers canvassed the area and the subject was located at the above location.

When Ofc E Andrade was getting out of his car, the subject began to quickly walk away, ignoring orders to stop. The subject was later identified as Matthew Stong 7.5.87. Stong fled east on Lazy Way Lane and circled around the music studio back to the Lane and onto Elizabeth St. Ofc. Andrade deployed 1 cartridge as Stong began to run and then a 2nd cartridge as he rounded the studio. When Ofc. Andrade caught up with Stong he grabbed his upper back and redirected him to the ground in a controlled manner (pulled him down).

Ofc, Andrade nor Stong were injured in this incident. Two probes were removed from Stong by Ofc. I Golovanov. KWFR responded to the scene to evaluate Stong. Stong did not display any outstanding issues. Stong was later taken to the ER by Ofc M Brablc and Ofc. A Dixon for medical clearance based on his excited state (later admitted to taking METH, COCAINE, and ADDERALL). Ofc. M Brablc completed the arrest affidavit and report.

On scene I spoke with a witness Muehlhauser who saw this portion of the incident. In addition, I responded to Ricks Bar and met with the original caller, Michael Tierney. I left a witness statement with him and instructions to call us back when complete.
