A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING A CHANGE ORDER TO SOUTHEAST TRUCK SPECIALIST FOR ADDITIONAL REPAIRS TO THE 2015 GILLIG LOW FLOOR BUS (UNIT 818) IN AN AMOUNT NOT TO EXCEED \$18,499.11, BRINGING THE TOTAL PROJECT \$64,804.15; TO PROVIDING REIMBURSEMENT FROM THE OTHER PARTY'S INSURANCE COMPANY; PROVIDING FOR COMPLIANCE WITH FEDERAL TRANSIT ADMINISTRATION (FTA) AND FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) REQUIREMENTS; PROVIDING FOR AN **EFFECTIVE** DATE.

WHEREAS, in early May 2025, Bus 818, a 2015 Gillig Low Floor Bus, sustained substantial structural damage in a collision and was removed from service due to safety concerns; and

WHEREAS, an initial repair estimate of \$47,000.00 was based on photographic evidence provided by Transit personnel;

WHEREAS, the Federal Transit Administration (FTA), through Florida Department of Transportation (FDOT) guidelines, mandates that federally funded transit vehicles be maintained in a state of good repair, be safe to operate, and meet minimum useful life standards; and

WHEREAS, the City of Key West is seeking full reimbursement for the repair costs from the other party's insurance company; and

WHEREAS, the City Manager recommends approval of a Change Order to Southeast Truck Specialist in an amount not to exceed \$18,499.11, bringing the total project cost to \$64,804.15;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: The City Commission hereby authorizes a Change Order to Southeast Truck Specialist for additional repairs to Bus 818 in an amount not to exceed \$18,499.11, bringing the total project cost to \$64,804.15.

Section 2: That the City shall pursue reimbursement from the other party's insurance company for full cost of the repairs.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
