A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING FAIR INSURANCE RATES IN MONROE TO CONDUCT A BIKE RIDE ON SUNDAY NOVEMBER 7, 2010 FROM 8AM TO 1PM ; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE CLOSURE OF REYNOLDS STREET FROM ATLANTIC BOULEVARD TO CASA MARINA COURT; WHITE STREET FROM ATLANTIC BOULEVARD TO CASA MARINA COURT; CASA MARINA COURT FROM WHITE STREET TO REYNOLDS STREET; ATLANTIC BOULEVARD CLOSURE PREVIOUSLY APPROVED BY MONROE COUNTY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Fair Insurance Rates In Monroe (FIRM). wishes to conduct a bike ride fund raiser.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Key West, Florida;

SECTION 1. That Fair Insurance Rates in Monroe (FIRM) is hereby granted permission to conduct a bike ride fundraiser ; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; that the organization meet the terms and conditions set forth by the City Manager., including insurance coverage for all event dates and activities.

SECTION 2. That Fair Insurance Rates in Monroe (FIRM) is hereby granted permission for the following street closures on Sunday, November 7, 2010 from 8:AM to 12:30 PM; Reynolds Street from Atlantic Boulevard to Casa Marina Court; White Street fro Atlantic Boulevard to Casa Marina Court; Casa Marina Court from White Street to Reynolds Street; (Atlantic Boulevard closure previously approved by MONROE COUNTY).

SECTION 3. That Fair Insurance Rates in Monroe (FIRM) is hereby granted a

Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place and time herein described.

SECTION 4. Fair Insurance in Monroe (FIRM) will adhere to the recycling plan of the City of Key West.

SECTION 5. This Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
