**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING SLOPPY JOE'S BAR TO CONDUCT AN EVENT FOR MOTORCYCLE BIKE WEEK ON SATURDAY, SEPTEMBER 19, 2015 FROM 12:00 NOON TO 11:00 P.M.; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE CLOSURE OF GREENE STREET BETWEEN DUVAL AND ANN STREETS FROM 11:00 A.M. TO 12:00 MIDNIGHT; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, Sloppy Joe's wishes to conduct a Biker Garden as a fundraiser for the Key West Sunrise Rotary Club and the Diabetes Research Institute Foundation, Inc; and

**NOW, THEREFORE, BE IT RESOLVED** by the City Commission of the City of Key West, Florida;

**SECTION 1.** That Sloppy Joe's Bar is hereby granted permission to conduct a Biker Garden on the day and during the hours stated above; **PROVIDED** that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; that the organization meet the terms and conditions set forth by the City Manager and that 25% of gross revenue or \$1000.00, whichever is greater shall be donated to Key West Sunrise Rotary Diabetes Research Institute Foundation, Inc.

**SECTION 2.** That Sloppy Joe's Bar is hereby granted permission for the closure of Greene Street between Duval and Ann Streets on the date and during the hours stated above.

**SECTION 3.** That pursuant to Section 18-86 of the Key West Code of Ordinances, Sloppy Joe's is hereby granted permission allowing the sale and consumption of alcoholic beverages within the enclosed area.

**SECTION 4.** That Sloppy Joe's will adhere to the recycling plan of the City Of Key

**SECTION 4.** That Sloppy Joe's will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.
