A regular meeting of the City Commission of the City of Key West, Florida was held in Commission Chambers, Old City Hall, on Tuesday, May 18, 2010.

Mayor Craig Cates called the meeting to order at 6:01 p.m.

(a) City Attorney's Report

The City Attorney asked for a closed Session with the Commission regarding

Case 2007-CA68K - Grosscup. He requested to hold the meeting at 5:15 P.M. on June 1 prior to the scheduled City Commission meeting.

(b) City Manager's Report

The City Manager discussed the Deep Water Horizon oil spill and the potential impact on Key West. The Coast Guard Sector Commander Captain DeQuattro, who serves as the Federal Government's representative in charge of the Keys, opened up the Oil Spill Liability Trust Fund through the Federal Government allowing the government to assist with the sampling of tar balls found in the Keys. The Coast Guard sent the recently discovered tar balls in Key West to Connecticut for analysis in determining the origin and if they are related to the oil spill. Currently the oil spill and tar balls are separate and distinct from one another.

The City Manager is working on an inter-governmental coordination process requested by Monroe County for the City to provide a technical review of a development proposal the County is looking at for Wisteria Island. In detail, a comprehensive and zoning change review is required by the City regarding certain support services that would be required depending on the type of development proposed such as impacts on services; waste management, solid waste, Police and Fire protection, parking and transportation. The County is only asking the City for technical review only.

The City Manager reported the preliminary environmental report was received on Glynn Archer School late in the afternoon prior to the City Commission meeting tonight and he stated he would provide a copy to the Commission as soon as the draft was complete. He also reported he attended the First Coast Guard District of Boston change-of-command ceremony for retiring Rear Admiral Joseph Nimmich.
