A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING FOGARTY'S TO CONDUCT A RED PARTY EVENT AT 227 DUVAL STREET ON WEDNESDAY, OCTOBER 24, 2012 FROM 12:00 NOON TO 4:00 A.M. PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE CLOSURE OF CAROLINE STREET BETWEEN DUVAL & SIMONTON STREETS FROM 8:00 A.M. TO 6:00 A.M.; GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES FROM 12:00 NOON TO 4:00 A.M.; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Fogarty's wishes to conduct a Red Party event on Wednesday, October 24, 2012 at Fogarty's 227 Duval Street.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Key West, Florida;

SECTION 1. That Fogarty's is hereby granted permission to conduct a "Red Party" Event on the day and during the hours stated above; **PROVIDED** that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; that the organization meet the terms and conditions set forth by the City Manager; and that 25% of gross revenue or \$1,000.00, whichever is greater, shall be donated to Monroe County Schools.

SECTION 2. That Fogarty's is hereby granted permission for the closure of Caroline Street between Duval and Simonton Streets on the date and during the hours stated above.

SECTION 3. That Fogarty's is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place and time herein described.

SECTION 4. That pursuant to Section 18-86 of the Key West Code of Ordinances, Fogarty's is hereby granted permission allowing the sale and consumption of alcoholic beverages

within the enclosed area.

SECTION 5. That Fogarty's will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

SECTION 6. This Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
