A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE WESLEY HOUSE TO CONDUCT IT'S ANNUAL "VALENTINE'S DAY FUNDRAISER" AT THE CURRY MANSION LOCATED AT 511 CAROLINE STREET ON MONDAY, FEBRUARY 14, 2011, FROM 9:00 A.M. TO 11:30 P.M; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE CLOSURE OF CAROLINE STREET FROM DUVAL TO SIMONTON STREETS AND ANN STREET FROM GREENE TO CAROLINE STREETS FROM 9:00 A.M. TO 11:30 P.M; GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES FROM 9:00 A.M. TO 11:00 P.M; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE BARRICADED AREA; PROVIDING FOR AN EFFECTIVE DATE

NOW THEREFORE, BE IT RESOLVED, by the City Commission of the City of Key West, Florida;

SECTION 1. That the Wesley House is hereby granted permission to conduct "Valentine's Fundraiser" on the days and during the hours stated above; PROVIDED all trash is adequately collected and contained; guarantee indemnifying the city is executed; and provided the organization meet the terms and conditions set forth by the City Manager, and 25% of gross revenue or \$1,000.00, whichever is greater shall be donated to the Wesley House Family Services.

SECTION 2. That the Wesley House is hereby granted permission for the closure of Caroline Street between Duval and Simonton Streets and Ann Street from Greene Street to Caroline Street on the date and during the hours stated above.

SECTION 3. That the Wesley House is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place and time herein described.

SECTION 4. That pursuant to Section 18-86 of the Key West Code of Ordinances,

permission is granted to allow the sale and consumption of alcoholic beverages within the enclosed area.

SECTION 5. That Wesley house will adhere to the recycling plan of the City of Key West.

SECTION 6. That this resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
