### **2.1. Document Design**

We are conversant with SUNGUARD Public Sector and can ingest the PDF output from their systems.

### **2.2. Data Processing**

In addition to supporting most data formats, Data Integrators also has implemented in-line mail integrity based processing. We read bar codes on each and every mil piece to ensure 100% mailing compliance and that where there are multi-page documents they are 100% verified. We make on-line dashboards available to clients to see all reports.

### **2.3. Bill Imaging and Retrieval**

The mail integrity camera systems allow us to suppress or 'pull' documents at any stage in the production process.

### **2.4. Document Format**

Our response calls for the use of paper as specified and we can produce both single and multi-page documents. DI is also a certified manifest mailer so we can mail packages with different piece weights in the same mail stream. This reduces postage costs by increasing the density of mail.

### **2.5. Document Print Mail Services**

Mail will be presented to the USPS within 24 hours of receipt of the data. If files are received by 3AM they will be mailed the same day.

## 2.6. Postal Requirements

All data is preprocessed through PAVE certified software including CASS and NCOA. We will sort to the lowest possible postage rate in all circumstances. In addition to supplying the IMB we can provide both outgoing and return mail tracking.

## 2.7. Reporting and Tracking Services

Through a series of dashboards, our clients are able to view all of the requirements and processes as the mail moves through the



facility.

## 2.8. Security Requirements

Data Integrators is a major vendor to the IRS, Medicare and the Social Security Administration, all of whom have very stringent security requirements on the personal information they provide us. Background checks are a part of our INFOSEC policy, which is available for review. Our facilities are well secured and the INFOSEC policies deal with issues such as data classification, security, network access, passwords, workstation policies, software and hardware configuration and maintenance, file transmission and data destruction.

Multi factor authentication and data security (in transit and at rest) are covered in the INFOSEC policy.

We have a secondary site that serves as a full disaster recovery facility.

## 2.9. Emergency Recovery

As a part of the implementation we can setup and test the DR process.

#### 3.1. Minimum Requirements

#### 3.2. Background Information

In 2010 we added a workflow tool that provides our clients with a portal to view their work on a dashboard as it progresses through the production cycle. ### 3.3. General Implementation Requirements

Data Integrators will provide all materials, equipment staffing and expertise necessary to meet the requirements of this RFP. Inventory management, postage and production reporting will be provided through our on-line portal.

Training will be provided on-site at the City of Key West's location of preference.

### 3.6. Qualifications

Data Integrators has been providing billing services since we started in 1999. Our services have migrated from pure print and mail to a hybrid of physical and electronic delivery. We support all distribution methods (mail, email, and internet) and consumer devices (computer, smartphone, and tablet). In addition to providing the distribution we offer marketing initiatives to encourage consumer migration to paperless.

We also have the ability to produce a much wider range of documents for the City and with our manifest mailing capabilities we can combine mailings to reduce postage.

We utilize state of the art processes for project management and as a part of the implementation create time lines (sample below), Statements of Work (SOW) and a Service Level Agreements (SLAs). These documents are the foundation for expectations between our business and a guideline of expectations (for training) for our associates.





We can explore selective inserting to see if this can be a revenue source for the city. If not already implemented we would use this to at least suppress inserting reply envelopes to those who pay on line.

We will initiate a cost and continuous improvement program that will look for ways to reduce costs for the City. This will be supported by quarterly meetings to review options and opportunities.
