An Ordinance of the City of Key West, Florida, adopting an Ad Valorem Tax General Municipal Millage Rate for FY 2025-2026; Providing for severability; Providing for repeal of inconsistent provisions; Providing for an effective date. BE IT ORDAINED BY THE CITY OF KEY WEST, FLORIDA: That the final adopted ad valorem tax general municipal millage rate for FY 2025-2026 is hereby set at 1.9739 1.9551 mills (\$1.9739 \$1.9551 per thousand dollars of assessed property value). The 2025-2026 final adopted millage rate is equal to 5.00 4.00 percent more than the rolled back rate of 1.8799 mills (\$1.8799 per thousand dollars of assessed property value).

Commissioner Carey made a motion to amend the FY 2025-2026 millage rate to 1.9551 which is equal to 4.00 percent more than the rolled back rate of 1.8799 mills. The motion failed due to lack of a second.

Vice Mayor Lee passed the gavel to Commissioner Kaufman.

A motion was made by Vice Mayor Lee, seconded by Commissioner Carey, that the Ordinance be Passed to Second Reading with changing the mills to 1.9551 which is 4.00 percent more than the rolled back rate. The motion carried by the following vote:
