A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING A 181-DAY TIME EXTENSION FOR CHARLEY TOPPINO AND SONS, INC. FOR THE VFD UPGRADES TO WASTEWATER PUMP STATIONS A, B, C, D and DA, PROJECT NO. SE-1301, AT NO ADDITIONAL COST; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY DOCUMENTS UPON ADVICE AND CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution 15-249, the City Commission awarded the bid of Charley Toppino and Sons, Inc. for VFD Upgrades to Wastewater Pump Stations A, B, C, D and DA; and

WHEREAS, the VFD drive manufacturer has experienced a delay in the design portion of the process, however City staff and the project engineer, CH2M HILL, believes that the manufacturer remains the best vendor for this essential component of the project; and

WHEREAS, City staff and CH2M HILL find that an extension of the contract is warranted and outside of the control of the contractor;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the contract completion date for VFD Upgrades to Wastewater Pump Stations A, B, C, D and DA

(project SE-1301) is extended for one hundred and eighty-one (181) calendar days, at no additional cost.

Section 2: That the City Manager is authorized to execute any necessary documents, upon the advice and consent of the City Attorney.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
