**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, SPONSORING A HOLIDAY SEASON PARADE ON SATURDAY, DECEMBER 4, 2021 BETWEEN THE HOURS OF 7:00 P.M. AND 10:00 P.M. (SETTING UP AT AROUND 3:30 P.M AT BAYVIEW PARK) AUTHORIZING THE CLOSURE OF CERTAIN STREETS FOR THE PARADE; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS** the City Commission desires to provide an annual holiday season gift to the community in the form of a parade; and

**NOW, THEREFORE, BE IT RESOLVED** by the City Commission of the City of Key West, Florida, as follows:

**SECTION 1.** That in Resolution 19-174, the City Commission directed the City Manager to “develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the local government for the provision of good or services, unless such use is otherwise preempted by law”

**SECTION 2.** “That the vendor/lessee/licensee acknowledges the City’s concern about the negative environmental impact of using disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/Lessee/licensee/contractor therefore commits to refrain from the use of polystyrene/plastic straws, bags, plastic utensils and “to go” packages for food or products sold on any property leased from the City”

**SECTION 3.** That it hereby sponsors a holiday season parade on Saturday, December 4, 2021, between 7:00 p.m. and 10:00 p.m.

**SECTION 4.** That the City's holiday season parade shall be open to the participation of any religious organization, school, or other sponsoring group whose participation shall be limited to a holiday season theme.

**SECTION 5.** That all provisions of the Code of Ordinances with respect to a parade on the City right-of-way shall be observed.

**SECTION 6.** That the parade will begin on the corner of Truman Avenue and White Street, go down Truman Avenue, turn right on Duval Street and end on Eaton Street.

**SECTION 7.** That the applicant acknowledges this authorization may be revoked by the Commission or the City Manager, due to exigent circumstances such as the resurgence of COVID-19 in the community.

**SECTION 8.** That the City Manager is recommending limiting the number of entries submitting applications.

**SECTION 9.** That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
