A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, DIRECTING THE CITY MANAGER TO ENGAGE IN DISCUSSION WITH THE FLORIDA KEYS MOSQUITO CONTROL DISTRICT ABOUT THE CURRENT AND FUTURE LOCATION OF ITS FACILITIES, IN ORDER TO CONTINUE TO EFFICIENTLY SERVE THE CITIZENS OF KEY WEST AND THE FLORIDA KEYS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Florida Keys Mosquito Control District (the "District") is currently developing plans to construct new facilities for its operations; and

WHEREAS, the City Commission finds that District staff efficiently provides mosquito control services which support and enhance the quality of life for all residents of Key West and the Florida Keys; and

WHEREAS, the City Commission recognizes that safe and effective mosquito control must remain a top priority of local government (city and county), and that the District has adequate facilities to provide those services;

WHEREAS, the City Commission recognizes the importance of cooperation and support between government agencies, including the District, in their common mission to protect the health and welfare of the public; and

WHEREAS, the City Commission seeks to open discussions with District staff and Board Members in order to find ways to reduce taxes, lower expenses and ensure that offices are located where District staff can best serve all constituents;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That the City Manager is hereby directed to engage in discussion with the Florida Keys Mosquito Control District about the current and future location of its facilities, and related ways City can assist the District to most efficiently serve the citizens of Key West and Monroe County.

Section 2: That the City Manager is directed to report on the results of discussion to the City Commission within 90 days.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
