A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AUTHORIZING THE KEY WEST POLICE DEPARTMENT TO ACCEPT A 2018-2019 HIGH VISIBILITY PEDESTRIAN AND BICYCLE SAFETY ENFORCEMENT (HVE) FUNDING GRANT FROM THE FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) VIA A CONTRACT ADMINISTERED BY THE UNIVERSITY NORTH FLORIDA'S TRAINING AND SERVICES INSTITUTE, INC. d/b/a INSTITUTE OF POLICE TECHNOLOGY AND MANAGEMENT (IPTM) IN THE AMOUNT \$16,643.73; AUTHORIZING ANY **NECESSARY** BUDGET TRANSFERS; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, FDOT, through a grant with the IPTM, is partnering with law enforcement to support efforts to educate and enforce safe pedestrian, bicyclist, and driver behaviors; and

WHEREAS, the KWPD intends to use the grant funding to implement effective community-level high-visibility enforcement and education operations at the six crosswalks along North Roosevelt Boulevard; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached FDOT HVE High Visibility Pedestrian and Bicycle Safety Enforcement Funding grant via a contract administered by University of North Florida's Training and Services Institute, Inc., d/b/a Institute of Police Technology and Management, in the amount of \$16,643.73, is hereby accepted for use by the Key West Police Department.

Section 2: That budget amendments to reflect receipt and allocation of the grant are hereby authorized.

Section 3: That the City Manager is hereby authorized to execute the grant agreement, upon the advice and consent of the City Attorney, on behalf of the Key West Police Department.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
