A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE PROCUREMENT OF HAZARDOUS MATERIALS (HAZ-MAT) PHYSICALS FOR A PERIOD OF UP TO TWO YEARS AT A COST OF \$638.00 PER CANDIDATE, AUTHORIZING UP TO A TOTAL \$25,520.00 ANNUAL COST, FROM LIFE EXTENSION CLINICS, INC. DBA LIFE SCAN WELLNESS CENTERS THROUGH PIGGYBACKING ON THE CITY OF CLEARWATER'S CONTRACT #901107FD, PURSUANT TO SECTION 2-797(3) OF THE CODE OF ORDINANCES; AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, this procurement will be made under the government contract - City of Clearwater RFP#51-20/Contract #90117FD, pursuant to section 2-797(3) of the Code of Ordinances.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the procurement of HAZ-MAT physicals for members of the KWFD HAZ-MAT team at a cost of \$638.00 per candidate, authorizing up to a total of \$25,520.00 annual cost, from Life Extension Clinics, Inc. dba Life Scan Wellness Centers, as described in the attached RFP/Contract #90117FD with the City of Clearwater, pursuant to Section 2-797(3) of the Code of Ordinances, is hereby authorized.

Section 2: That funds for HAZ-MAT Physicals are budgeted in account #001-2201-522-3100 (\$25,600.00 FY 21/22).

Section 3: That the City Manager is authorized to enter into a contract in substantial conformity with the City of Clearwater bid/contract documents upon the advice and consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
